### **The Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2010 (Amendment) (No. 1) 2010**

Coming into force on... 1<sup>st</sup> September 2010

Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of the powers conferred on that County under sections 1, 2, 4, 45, 46, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and Part 6 of The Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into force on 1<sup>st</sup> September 2010 or at a later date and may be cited as The Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2010 (Amendment) (No. 1) 2010.
2. In this Order, the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Borough of Watford (Watford Central Area And West Watford) (Controlled Parking Zones) (Consolidation) Order 2010(b) shall have effect as though:
  - (a) there were added to Schedule 1 to that Order the items set out in columns 1, 2 and 3 of Schedule 1 to this Order as is indicated in Schedule 1 to this Order;
  - (b) there were added to Schedule 4 to that Order the items set out in columns 1, 2 and 3 of Schedule 2 to this Order as is indicated in Schedule 3 to this Order;

- (c) there were added to that Order the Schedules as set out in Schedule 3 to this Order as Schedules 30, 31, 32 and 33 to that Order;
- (d) there were added to Schedule 26 to that Order under the heading The Cassiobury Zones the list of roads entitled Parking Zone V as set out in Schedule 4 to this Order;
- (e) there were substituted within Schedule 26 to that Order the list of roads entitled "Parking Zone D:" with the similarly titled list of roads set out in Schedule 5 to this Order;
- (f) In Article 2 within the section headed "The Permitted Hours" there were added "d) in the Cassiobury Zones: the Cassiobury Hours" and at the end "the Cassiobury Hours" means the period between 10.30 am and 2.30 pm on Mondays to Fridays inclusive from January 1st to June 30th and from September 1st to December 31st (both inclusive), any such day not being Christmas Day.";
- (g) In Article 2 within the paragraph that begins "Controlled Parking Zone" or "CPZ" the wording "... and "Match Day Only Zones" respectively..." was substituted by "..., "Match Day Only Zones" and "Cassiobury Zones" respectively...";
- (h) In Article 2 within the paragraph that begins "outer parking zone" the wording "...Parking Zones K, L, S and T." was substituted by " ...Parking Zones K, L, S, T and V.";
- (i) In Article 6 in sub clause (1) the wording "...Schedules 2 and 3..." were substituted by "... Schedules 2, 3 and 30..."

and

in sub clause (2) after the wording "...the CPZ Extended Hours..." there were added "...or in the Cassiobury Zones as referred to in Schedule 30 during the Cassiobury Hours...";

- (j) for Article 10(1) there were substituted the following:

"Each area on a highway

- (a) comprising the length of carriageway of a street specified in columns 1, 2 and 3 of Schedule 4 and which contains the words "whole width" in column 2 (delete) of the same row of that Schedule for that area and which shall, unless otherwise so specified in Schedule 20 of the Order, comprise the whole width of the highway;
- (b) not referred to in sub-paragraph (a) above and comprising the length of carriageway of a street specified in column 3 of Schedules 4, 5, 6, 7, 8, 9, 10, 11, 12, 14 and 24 which shall, unless otherwise so specified in Schedule 25 of the Order, be bounded on one side of that length by the edge of the carriageway and having a width throughout of 1.83 metres;

is hereby designated as a parking place."

- (k) in Article 13 in sub clause (2) the wording "...Schedules 4, 5 and 6..." were substituted by "... Schedules 4, 5, 6 and 31...";

and

at the beginning of sub clause (3) the wording "Parking places referred to in Schedules 7 or 8..." were substituted by "Parking places referred to in Schedules 7, 8 and 33..."

and

under sub clause (3) (a) the wording "... a period of either 1 or 2 or 4 hours as specified for each parking place in column 4 of Schedules 7 or 8..." was substituted by "...a period of either 1 or 2 or 3 or 4 hours as specified for each parking place in column 4 of Schedules 7 or 8 or 33..."

and

in sub clause (4) the wordings "...Schedules 9 or 10..." were substituted by "... Schedules 9 or 10 or 32..." and the wording "... a period of either 1 or 2 or 4 hours..." were substituted by "...a period of either 1 or 2 or 3 or 4 hours...";

- (l) for Article 30(b)(i) there were substituted the following:

"(i) if the parking place is not in a one-way street, nor a parking place referred to in Article 10(1)(a), that the left or near side of the vehicle is adjacent to the left-hand edge of the carriageway; and";

- (m) In Article 34 sub clause (a) Schedules 31, 32, and 33 were added to the Schedules listed.

- (n) for Article 41 there were substituted the following;

"The initial charge for a vehicle (other than a vehicle otherwise exempted by this Order) left in a parking place referred to in Schedule 7, 8, 9, 10, 12, 13, 32 and 33 during the permitted hours shall be as described in Table One below and shall apply for up to a maximum parking period of either one hour, two hours, three hours or four hours, as specified for each parking place in Schedules 7, 8, 9, 10, 12, 13, 32 and 33.

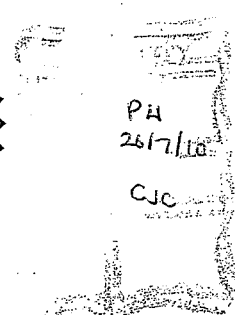
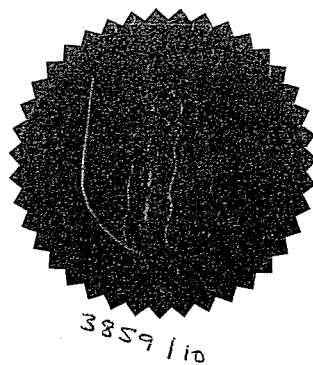

- (o) in Article 51 (4) there were substituted the wording "...except Parking Zones E, J, K, L, M, N, S and T ..." with "...except Parking Zones E, J, K, L, M, N, S, T and V...";
- (p) in Article 60 Schedules 31 and 33 were added to the Schedules listed.
4. Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into operation of this Order:
- (a) The Borough of Watford (South Watford) (Prohibition & Restriction of Waiting) (Consolidation) Order, 1974(c) shall have effect as though the items relating to Cassiobury Drive, Dellfield Close, Stratford Way and Woodland Drive in Schedule 1 to that Order, the item relating to Stratford Way in Schedule 2 to that Order and the item relating to Stratford Way in Schedule 4 to that Order were hereby revoked;
- (b) The Borough of Watford (Park, Nascot and Leggatts Area) (Prohibition & Restriction of Waiting) Order 1998(d) shall have effect as though the items numbered 12 and 14 in Schedule 2 to that Order were hereby revoked;
- (c) The Borough of Watford (Nascot Area & Woodland Drive) (Prohibition & Restriction of Waiting) Order 1999 shall have effect as though the item numbered 4 in Schedule 2 to that Order were hereby revoked; and
- (d) The Borough of Watford (Various Streets, Watford) (Restriction and Prohibition of Waiting) Order 2008(e) shall have effect as though the items numbered 45(a)(ii), 45(b)(ii), 54 and 56 in Schedule 1 to that Order were hereby revoked.

The Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2010 (Amendment) (No. 1) 2010 (a) should be corrected as follows:

(1) In Schedule 3 to that Order, the items listed below shall be omitted.

Cassiobury Drive	north-east	Between a point 10.5 metres south-east of the south-eastern kerb-line of Stratford Way and a point 40 metres north-west of the western kerb-line of Woodland Drive
Cassiobury Drive	north-east	Between a point 6.8 metres south-east of the common boundary of Nos. 46 and 48 Cassiobury Drive and a point 4 metres west of the common boundary of Nos. 4 and 6 Cassiobury Drive
Stratford Way	south-east	Between a point 2 metres south-west of the south-western boundary of No. 19 Stratford Way and the common boundary of Nos. 3 and 5 Stratford Way
Woodland Drive	north-east	Between a point 3 metres south-east of the common boundary of Nos. 30 and 32 Woodland Drive and a point 4.7 metres north-west of the common boundary of Nos. 2 and 4 Woodland Drive

(3) Article 4(c) shall be omitted in its entirety.
