## ROAD TRAFFIC REGULATION ACT 1984

**THE HERTFORDSHIRE (ST ALBANS ROAD and LEAVESDEN ROAD, WATFORD)  
(PARKING PLACES) ORDER 1998**

The Hertfordshire County Council in exercise of their powers under Sections 32(1) and 35(1) of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:-

1. This Order may be cited as "The Hertfordshire (St Albans Road and Leavesden Road, Watford) (Parking Places) Order 1998" and shall come into operation on .
2. Save as provided in Articles 3 and 4 of this Order, the lengths of road specified in the Schedule are authorised for use as parking places for loading and unloading.
3. Where in Article 2 of this Order a parking place is described as authorised for use as a parking place, the driver of a vehicle shall not permit the vehicle to wait in that parking place unless it is:
  - (a) a commercial vehicle being loaded from or unloaded to premises adjacent to the parking place;
  - (b) wholly within the marked limits of the parking place.
4. Nothing in Article 2 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of roads specified therein for so long as may be necessary to enable: -
  - (a) a person to board or alight from the vehicle;
  - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely
    - (i) building, industrial and demolition operations;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance, improvement or reconstruction of the said length of road;
    - (iv) the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;

(v) ~~fire and rescue service~~, ambulance or police purposes;

- (c) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
- (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953.

5. The provisions of the following Traffic Regulation Orders insofar as they relate to the area of the parking places created by this Order are hereby revoked:-
  - (i) The Borough of Watford (North Watford) (Prohibition and Restriction of Waiting) Order 1972,
  - (ii) The Borough of Watford (North Watford) (Prohibition and Restriction of Waiting) Order 1972 (Amendment) Order 1981.
6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
7. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

| Leavesden Road<br>- north east side | (c) from a point 14 metres north of the centreline of its junction with Terrace Gardens northwards for a distance of 15 metres.<br><br>(d) from a point 30 metres north west of its junction with St Albans Road north westwards for a distance of 20 metres |
