THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (AMENDMENT) (NO. 4) ORDER 2011

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council, and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Road Traffic Regulation Act 1991 and Part 6 of the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

- This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (AMENDMENT) (NO. 4) ORDER 2011 and shall come into operation on 10th October 2011.
- The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
- 4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (the "2010 Order") shall be amended in accordance with the Articles 5 to 10 of this Order.
- 5. The sides of road referred to in columns 1, 2 and 3 of the Schedule to this Order shall be added to the parts of Schedules 1 and 4 of the 2010 Order as are indicated in Schedule 1 to this Order.
- Schedule 2 of this Order shall be added to the 2010 Order as Schedule 30A of that Order.
- In Article 6 (1) "the wording "Schedules 2, 3, 30 and 35" shall be substituted by "Schedules 2, 3, 30, 30A and 35".
- In Schedule 4 of the 2010 Order items referred to in columns 1 and 2 under Zone D as Woodville Court north east side and Woodville Court south west side shall be deleted
- Schedule 26 of the 2010 Order shall be amended by the addition under the heading The CPZ Standard Zones: Parking Zone D of the following addresses:-Kenilworth Court, Kildonan Close and Oaklands Court.
- 10 In Schedule 30 of the 2010 Order the items referred to in column 1 under Zone D as Dellfield Close and as Woodville Court shall be deleted.

- The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (AMENDMENT) (No. 1) ORDER 2010 shall be amended in accordance with the Articles 12 and 13 of this Order.
- In paragraph (b) of Article 3 the words "Schedule 3 to this Order:" shall be replaced by the words "Schedule 2 to this Order;".
- In paragraph (j) (a) of Article 3 the words "(delete) of the same row of that Schedule for that area and which" shall be deleted.
