THE BOROUGH OF WATFORD (OFF-STREET PARKING PLACES) ORDER 2007 (AMENDMENT) (NO. 4) ORDER 2012

The Watford Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act of 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council in exercise of the powers conferred by Sections 32, 35 and 35A of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Schedule 3 of the Road Traffic Act 1991 ("the 1991 Act") and in accordance with the provisions of Part 6 of The Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order.

- 1. This Order shall come into operation on 22nd October 2012 and may be cited as "The Borough of Watford (Off-Street Parking Places) Order 2007 (Amendment) (No.4) Order 2012" hereinafter referred to as "this Order".
- 2. The Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2010 shall hereinafter be referred to as "The CPZ Consolidation Order"
- 3. The provisions of The Borough of Watford (Off-Street Parking Places) Order 2007 ("the 2007 Order") shall be amended in accordance with the Articles 4 to 6 of this Order.
- 4. The Schedule of this Order shall be added to the 2007 Order as Schedule 4.
- 5. In Articles 2, 3 and 5 of the 2007 Order the words "Schedule 1, 2 or 3" shall be replaced by the words:- "Schedule 1, 2, 3 or 4."
- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
