Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000(a) and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000(b) with the Hertfordshire County Council, and in exercise of the powers conferred on that County under Sections 1, 2(1), 2(2), 4, 45, 46(1), 49, 51, 53 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984(c) ("the Act of 1984") and the Road Traffic Act 1991(d) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:


- This Order shall come into operation on 20<sup>th</sup> May 2013 and may be cited as The Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2010 (Amendment No. 6) Order 2013.
- 2. In this Order, the expression "enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment and any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Borough of Watford (Watford Central Area and West Watford) (Controlled Parking Zones) (Consolidation) Order 2010("The Order of 2010")(e) shall have effect as though:
  - (a) there were added to Schedule 31 to that Order the item set out in columns 1, 2 and 3 of the Schdule to this Order; and
  - (b) any reference in Schedule 30 or 31 to that Order to a length of street in Orchard \* Drive is hereby omitted.
