**THE BOROUGH OF WATFORD
(OFF-STREET PARKING PLACES) ORDER 2007
(AMENDMENT) (NO. 6) ORDER 2015**

The Watford Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act of 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 with Hertfordshire County Council in exercise of the powers conferred by Sections 32, 35 and 35A of the Road Traffic Regulation Act 1984 ("the 1984 Act") and Schedule 3 of the Road Traffic Act 1991 ("the 1991 Act") and in accordance with the provisions of Part 6 of The Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order.

1. This Order shall come into operation on 1st June 2015 and may be cited as "The Borough of Watford (Off-Street Parking Places) Order 2007 (Amendment) (No.6) Order 2015" hereinafter referred to as "this Order".
2. The provisions of The Borough of Watford (Off-Street Parking Places) Order 2007 ("the 2007 Order"), as amended, are hereby amended as indicated in Article 3 of this Order.
3. Schedule 1 of the 2007 Order shall be amended by the replacement of the existing section referring to The Avenue Car Park by the section set out in The Schedule to this Order..
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
