

WATFORD BOROUGH COUNCIL**THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (AMENDMENT) (NO13) ORDER 2015****Watford Council No. 790**

The Watford Borough Council, pursuant to arrangements made under Section 19 of the Local Government Act 2000 and the Local Government Arrangements for Discharge of Functions) (England) Regulations 2000 with the Hertfordshire County Council and in exercise of powers conferred on that County under Sections 1, 2, 4, 45, 46A, 47, 49, 51 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and the Road Traffic Regulation Act 1991 and Part 6 of the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This Order may be cited as THE BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (AMENDMENT) (NO13) ORDER 2015 and shall come in to operation on 24th December 2015.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The prohibitions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 by or under any other enactment.
4. The BOROUGH OF WATFORD (WATFORD CENTRAL AREA AND WEST WATFORD) (CONTROLLED PARKING ZONES) (CONSOLIDATION) ORDER 2010 (the "2010 Order") shall be amended in accordance with Articles 5 and 6 below.
5. The restrictions referred to in Schedules 1 2 and 3 to this Order shall be added to the Schedules of the 2010 Order.
6. The restrictions referred to in Schedule 4 to this Order shall be deleted from the Schedules of the 2010 Order.
