**THE HERTFORDSHIRE (A412 ST ALBANS ROAD and STATION ROAD, WATFORD)
(PROHIBITION AND RESTRICTION OF WAITING, LOADING AND UNLOADING) (No 2)
ORDER 1999**

The Hertfordshire County Council in exercise of their powers under Sections 1(1), 2(1) to (3) and 3 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Hertfordshire (A412 St Albans Road and Station Road, Watford) (Prohibition of Waiting, Loading and Unloading Restrictions) (No 2) Order 1999" and shall come into operation on Monday 13 September 1999.
2. Save as provided in Article 4 of this Order, no person shall, except under the direction or with the permission of a police officer in uniform or officer authorised by Watford Borough Council, cause or permit any vehicle to wait at any time for the purposes of loading or unloading goods to or from any vehicle in the lengths of A412 St Albans Road, Watford specified in Schedule 1 of this Order.
3. Save as provided in Article 4 of this Order, no person shall, except under the direction or with the permission of a police officer in uniform or officer authorised by Watford Borough Council, cause or permit any vehicle to wait between the hours of 7.00 am to 10.00 am and 4.00 pm to 7.00 pm for the purposes of loading or unloading goods to or from any vehicle in the lengths of A412 St Albans Road and Station Road, Watford specified in Schedule 2 of this Order.
4. Nothing in Articles 2 and 3 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein for so long as may be necessary to enable :-
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely
 - (i) building, industrial and demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said length of road;
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;
 - (v) fire brigade, ambulance or police purposes;

- (c) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953.
5. The provisions of the following Traffic Regulation Orders insofar as they relate to loading and unloading on lengths of St Albans Road affected by this Order are hereby revoked:-
- (i) The Borough of Watford (North Watford) (Prohibition and Restriction of Waiting) Order 1972,
 - (ii) The Borough of Watford (North Watford) (Prohibition and Restriction of Waiting) Order 1973,
 - (iii) The Borough of Watford (St Albans Road / Longspring) (Restriction of Waiting) Order 1977, and
 - (iv) The Hertfordshire (A412 St Albans Road, Watford) (Prohibition of Waiting, Loading and Unloading Restrictions) (No 1) Order 1998.
6. The restrictions imposed by this Order shall be in addition and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE 1

Lengths of road in Watford - No loading or unloading at any time

A412 St Albans Road
- east side

- (a) from a point 76 metres north of the centreline of its junction with the Odhams exit road southwards for a distance of 55 metres.
- (b) from a point 53 metres north of the centreline of its junction with Bushey Mill Lane southwards for a distance of 153 metres.

A412 St Albans Road
- west side

- (c) from a point 72 metres south of the centreline of its most southerly junction with Longspring northwards for a distance of 60 metres.
- (d) from its junction with the Dome roundabout southwards for a distance of 60 metres.

SCHEDULE 2

Lengths of road in Watford - No loading or unloading 7.00 am to 10.00 am & 4.00 pm to 7.00 pm

A412 St Albans Road

- west side

- (a) from a point 4 metres south of the centreline of its junction with the Odhams exit road southwards for a distance of 139 metres.

A412 St Albans Road

- west side

- (b) from a point 185 metres south of the centreline of its most southerly junction with Longspring northwards for a distance of 113 metres.

-west side

- (c) from a point 115 metres north of the centreline of its most northerly junction with Longspring northwards for a distance of 90 metres to a point 4 metres south of the centreline of its junction with Leggatts Wood Avenue.

-west side

- (d) from a point 40 metres south of the centreline of its junction with Leavesden Road northwards to a point 3 metres south of the centreline of its junction with Lowestoft Road a distance of 238 metres.

-west side

- (e) from a point 20 metres south of the centreline of its junction with Ridge Street to a point 72 metres south of the centreline of its most southerly junction with Longspring a distance of 632 metres.

-east side

- (f) from a point 22 metres north of the centreline of its junction with Balmoral Road southwards for a distance of 84 metres.

-east side

- (g) from a point 86 metres north of the centreline of its junction with Penn Road southwards to a point 66 metres north of the centreline of its junction with Station Road a distance of 369 metres.

Station Road

-south side

- (h) from a point 6 metres east of its junction with Westland Avenue eastwards for a distance of 27 metres.
