WHEREAS the Welwyn Hatfield District Council (hereinafter called "the Council") has resolved that the provisions of Part II, except Section 45, of the Local Government (Miscellaneous Provisions) Act, 1976 (hereinafter called "the Act") shall apply to the relevant area, namely so much of the area of the District of Welwyn Hatfield as is not included in the Metropolitan Police District and that the said provision came into force on the First day of April, 1978;

NOW THEREFORE the Council in pursuance of its powers under Section 63 of the Act hereby makes the following Order:-

- (1) The place specified as follows shall be appointed a stand for such number of Hackney Carriages as is specified:-

<u>Stand</u>	<u>Description</u>	<u>No.of Vehicles</u>
Cavendish Way [Service Road outside The Galleria], Hatfield	North east kerb side of the service road adjacent to the bus stop clearway for a length of 18 metres, as shown on the attached plan.	3

- (2) The rank specified in article 1 of this Order will operate between 7.00am and 8.00pm.
- (3) This Order shall come into operation on the fifteenth day of February, 1999 and may be cited as the District of Welwyn Hatfield (Cavendish Way [Service Road outside The Galleria], Hatfield) (Appointment of Hackney Carriage Stand) Order 1999. .

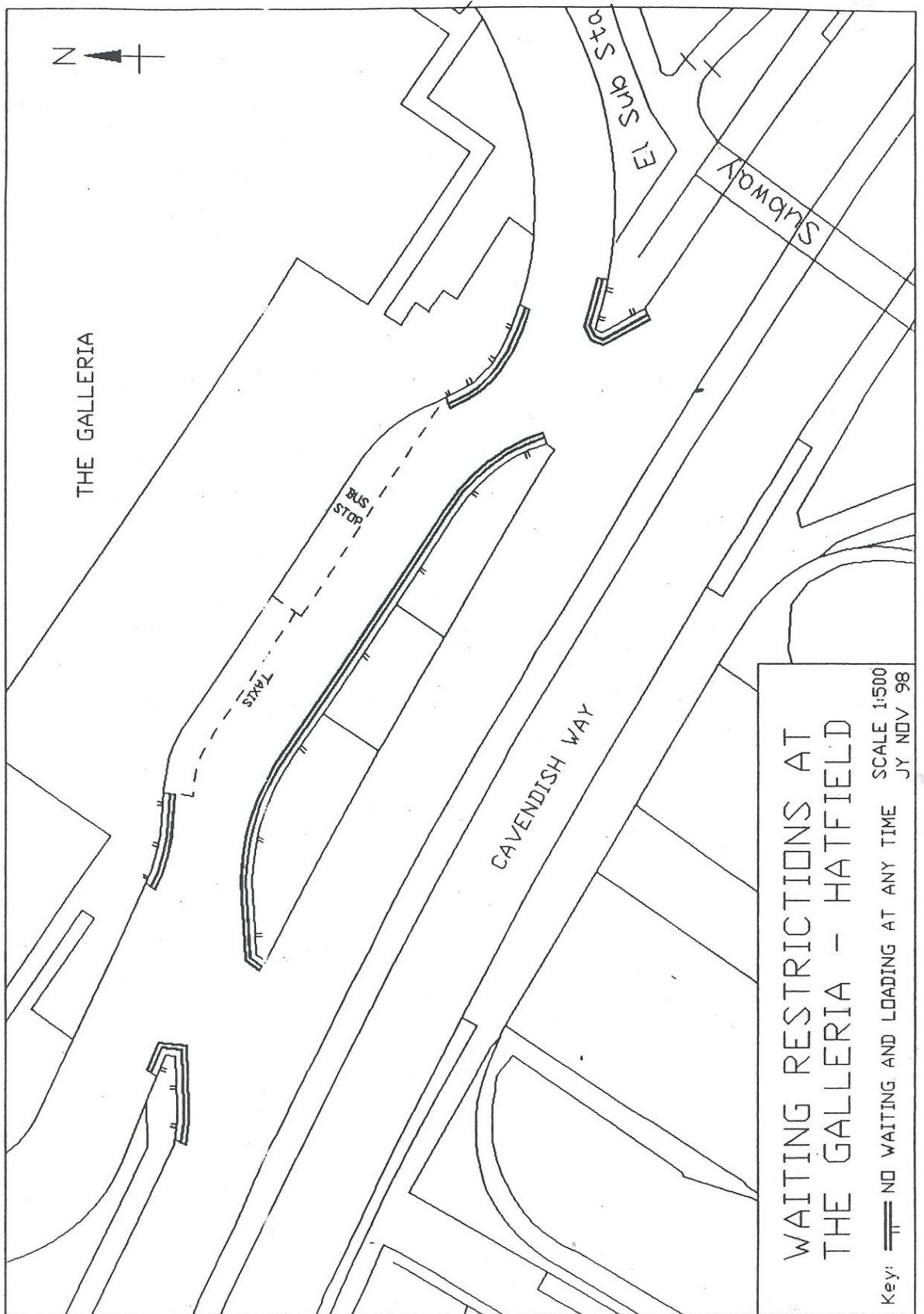

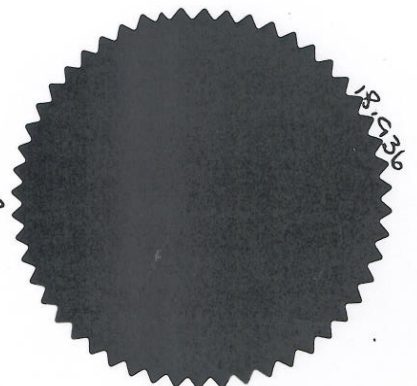
