### **ROAD TRAFFIC REGULATION ACT 1984**

# THE BOROUGH OF WELWYN HATFIELD (VARIOUS ROADS, BIRCHWOOD, HATFIELD) (RESTRICTION OF WAITING) ORDER 2019

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and The Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2012 in exercise of the powers conferred under Sections 1, 2, and 3 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:-

- This Order may be cited as "The Borough of Welwyn Hatfield (Various Roads, Birchwood, Hatfield) (Restriction of Waiting) Order 2019" and shall come into effect on Monday 12<sup>th</sup> August 2019
- 2. Save as provided in Articles 3, 4 and 5(1) of this Order, no person shall cause or permit any vehicle to wait at any time in those lengths of road specified in the Schedule to this Order.
- 3. (1) Nothing in Article 2 of this Order applies to the lengths of road restricted by those Articles (which said lengths of road are referred to in this Article as "the restricted area") in relation to-
  - (a) A vehicle being used for Fire and Rescue, Ambulance or Police purposes.
  - (b) Anything done with the permission of or at the direction of a police constable in uniform; or with the permission of a Civil Enforcement Officer as defined by the Traffic Management Act 2004 and appointed by Welwyn Hatfield Borough Council.
  - (c) A vehicle which is prevented from proceeding by circumstances beyond the drivers control or which has stopped in order to avoid injury or damage to persons or property or when required to do so by law;
  - (d) A vehicle which is stationary in order that it may be used for one or more of the purposes specified in sub-Article (2) of this Article and which cannot reasonably be used for such a purpose without stopping in the restricted area;
  - (e) A marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may be reasonably necessary for postal packets to be delivered or collected;

#### In this Article -

The expressions "universal service provider", "provision of a universal postal Service" and "postal packet" shall bear the same meanings as in the Section 65 of the Postal Services Act 2011.

- 3. (2) The "purposes" referred to in sub-Article (1)(d) of this Article are -
  - (a) any operation involving building, demolition or excavation;
  - (b) the removal of any obstruction to traffic;
  - (c) the maintenance, improvement or reconstruction of a road;
  - (d) constructing, improving, maintaining, or cleaning of any street furniture; or

- (e) the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.
- 4. Nothing in Article 2 of this Order applies to the lengths of road restricted by those Articles (which said lengths of road are referred to in this Article as "the restricted area") so as to render it unlawful to cause or permit any vehicle to wait only for so long as may be reasonably necessary
  - (a) To enable goods to be loaded on or unloaded from the vehicle from or to premises adjacent to the restricted area; or
  - (b) To enable a passenger to board or alight and to load and unload any luggage.
- 5. (1) Nothing in Article 2 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc, to wait at any time in the lengths of road specified in the Schedule of this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).

### (2) In this Article -

"disabled person's vehicle" has the same meaning as in Section 142(1) of the Act of 1984;

"disabled person's badge" has the same meaning as given in Regulation 3(1) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000

"parking disc" has the same meaning as given in Regulation 8(5) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000; and

"relevant position" has the same meaning as given in Regulation 4 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.

6. The provisions of the following Order are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order and the relevant schedule:
The Borough of Welwyn Hatfield (Control of Parking) (Consolidation) Order 2017

- 7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 8. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

NOTICE IS HEREBY GIVEN that the Welwyn Hatfield Borough Council (pursuant to arrangement made with Hertfordshire County Council) has made the above Orders under the Road Traffic Regulation Act 1984 to introduce restrictions in **Various Roads, Birchwood, Hatfield**, as specified in the Schedule(s) to this Notice. #### STATEMENT OF REASONS FOR PROPOSING

THE BOROUGH OF WELWYN HATFIELD (VARIOUS ROADS, BIRCHWOOD, HATFIELD) (RESTRICTION OF WAITING) ORDER 2019

THE BOROUGH OF WELWYN HATFIELD (VARIOUS ROADS, BIRCHWOOD, HATFIELD) (PROHIBITION OF STOPPING AND WAITING ON VERGE OR FOOTWAY) ORDER 2019

Welwyn Hatfield Borough Council is proposing to introduce "no waiting at anytime" (double yellow lines), and also a prohibition of stopping and waiting on verge or footway in Various Roads, Hatfield.

Residents and businesses of the area were consulted on proposed parking restrictions to prevent parking on junctions and congestion. Parking on verges and footways is an unnecessary obstruction and inconvenience to other road users and causes damage to the highway and underground services. Existing by-laws in force prohibit parking on grass verges, however current legislation does not allow their enforcement by Civil Enforcement Officers.

The proposed restrictions:

No waiting at any time

 In parts of Access Road to Birchwood Leisure Centre, Birchwood Close, Birchway, Branch Close, Burnside Close, Chelwood Avenue, Cornerfield, Crawford Road, Crop Common, Great Heath, Green Croft, Ground Lane, Heathcote Avenue, Hillfield, Homestead Road, Jubilee Court, Little Mead, Lockley Crescent, Longmead, Northfield, Talbot Road, Warren Close, Warren Green, West View, Wood Common

No stopping or waiting on verge or footway at any time

 In parts of Access Road to Birchwood Leisure Centre, Birchwood Avenue, Birchwood Close, Birchway, Branch Close, Chelwood Avenue, Cornerfield, Crawford Road, Drovers Way, Great Heath, Green Croft, Heathcote Avenue, Hillfield, Homestead Road, Little Mead, Lockley Crescent, Longmead, Northfield, Talbot Road, Warren Close, Warren Green, West View, Wood Common




- For the avoidance of danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising

- For facilitating the passage on the road or any other road of any class of traffic including pedestrians.


