ROAD TRAFFIC REGULATION ACT 1984

**THE BOROUGH OF WELWYN HATFIELD
WELWYN HATFIELD DISTRICT COUNCIL (OFF-STREET PARKING PLACES) ORDER 1995
(AMENDMENT NO 7) ORDER 2012**

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 in exercise of the powers conferred under Sections 32, 33, 34, 35 and 35A of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Borough of Welwyn Hatfield, Welwyn Hatfield District Council (Off-Street Parking Places) Order 1995 (Amendment No 7) Order 2012 " and shall come into operation on Monday 13 August 2012.
2. The Schedule to the Welwyn Hatfield District Council (Off-Street Parking Places) Order 1995 shall be amended by the replacement of that part referring to The Broadway Car Park with the Schedule to this Order.
3. The provisions of the following Order shall be revoked but only in so far as they relate to The Broadway Car Park - The Borough of Welwyn Hatfield, Welwyn Hatfield District Council (Off Street Parking Places) Order 1995 (Amendment No 6) Order 2010.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
5. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the act of 1984 or by any other enactment.
