ROAD TRAFFIC REGULATION ACT 1984

THE BOROUGH OF WELWYN HATFIELD (PEPLINS WAY, PEPLINS CLOSE, BRADMORE WAY AND BRADMORE GREEN, BROOKMANS PARK, HATFIELD) (RESTRICTION OF WAITING AND PERMIT PARKING ZONE) ORDER 2014 (AMENDMENT) ORDER 2016

The Welwyn Hatfield Borough Council (herein referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Government (arrangements for Discharge of Functions) (England) regulations 2000 in exercise of the powers conferred on the said County Council by Sections 32 and 35 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is herein referred to as "the Act of 1984") and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following Order:-

1. This Order may be cited as "**The Borough of Welwyn Hatfield (Peplins Way, Peplins Close, Bradmore Way and Bradmore Green, Brookmans Park, Hatfield) (Restriction of waiting and permit parking zone) Order 2014 (Amendment) Order 2016**" and shall come into operation on 30th August 2016.
2. (1) The Borough of Welwyn Hatfield (Peplins Way, Peplins Close, Bradmore Way and Bradmore Green, Brookmans Park, Hatfield) (Restriction of waiting and permit parking zone) Order 2014 herein after referred to as the '2014 Order' shall be amended as follows;
 - (i) Schedule 2 and Schedule 3 of 'the 2014 Order' shall be amended by insertion of amendments as specified in Schedules 1 and 2 to this Order.
 - (ii) Schedule 2 and Schedule 3 of the 2014 Order shall be amended by deletion of those items specified in Schedules 4 and 5 of this Order.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
4. The restrictions imposed by this order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by any other enactment.

Schedule 1 amending Schedule 2 of 'the 2014 Order' No waiting at any time		
Peplins Way (Southwest side)	b	From a point 3 metres southeast of a point in line with the common boundary between Nos 39 and 41 Peplins Way, northwest for a distance of 10.5 metres.
	c	From a point 4.5 metres northwest of a point in line with the common boundary between Nos 69 and 71 Peplins Way, northwest for an approximate distance of 43 metres, to a point in line with the projected southwest kerbline of Peplins Way.

Schedule 2 amending Schedule 3 of the 2014 Order Permit Parking Places only Monday to Friday 10am – 11am		
Peplins Way (Southwest side)	a	From a point 4.5 metres northwest of a point in line with the common boundary between Nos 29 and 31 Peplins Way, northwest for an approximate distance of 42 metres, to a point 7 metres northwest of a point in line with the common boundary between Nos 37 and 39 Peplins Way
	b	From a point 7.5 metres northwest of a point in line with the common boundary between Nos 39 and 41 Peplins Way, northwest for an approximate distance of 162 metres, to a point 4.5 metres northwest of a point in line with the common boundary between Nos 69 and 71 Peplins Way.
	c	From a point 4 metres southwest of a point in line with the projected southwest kerbline of Peplins Way, southwest, northwest, north, northeast, southeast and southwest for an approximate distance of 123 metres, to a point in line with the common boundary between Nos 103 and 105 Peplins Way

Schedule 3 Items for deletion from Schedule 2 of the 2014 Order No waiting at any time		
Peplins Way	c	From a point 4.5 metres northwest of a point in line with the boundary between Nos 69 and 71, northwest for a distance of 23 metres.

Schedule 4 Items for deletion from Schedule 3 of the 2014 Order Permit Parking Places only Monday – Friday 10am-11am		
Peplins Way	b	From a point 1 metre south east of the north west property wall of No 31, north west for an approximate distance of 214 metres, to a point 4.5 metres north west of the boundary between Nos 69/71
	c	From a point 2 metres north west of the north west property wall of No 75, north west then west in a clockwise direction around the cul-de-sac perimeter, for an approximate distance of 141 metres, to a point in line with the north west property wall of No 109

STATEMENT OF REASONS FOR PROPOSING

**THE BOROUGH OF WELWYN HATFIELD (PEPLINS WAY, PEPLINS CLOSE,
BRADMORE WAY AND BRADMORE GREEN, BROOKMANS PARK, HATFIELD)
(RESTRICTION OF WAITING AND PERMIT PARKING ZONE) ORDER 2014
(AMENDMENT) ORDER 2016**

Welwyn Hatfield Borough Council is proposing to introduce restrictions in parts of **Peplins Way, Brookmans Park**, consisting of waiting restrictions.

Acting upon the responses from a general parking survey in Brookmans Park, in 2015 the Council implemented a resident permit parking scheme together with junction protection (No waiting at any time) in parts of Peplins Way, Peplins Close, Bradmore Way and Bradmore Green, Brookmans Park. Subsequent to this, residents have now made requests for additional waiting restrictions to ease congestion and improve access to their property.

Having considered the duty imposed by Section 122 Road Traffic Regulation Act 1984, it appears to Welwyn Hatfield Borough Council that it is necessary and expedient to make Orders for the following reasons:-

- **In order to provide suitable and adequate parking facilities**
- **For the purposes of relieving or preventing congestion of traffic.**
- **For the avoidance of danger to persons or other traffic using the road and preventing the likelihood of any such danger arising.**

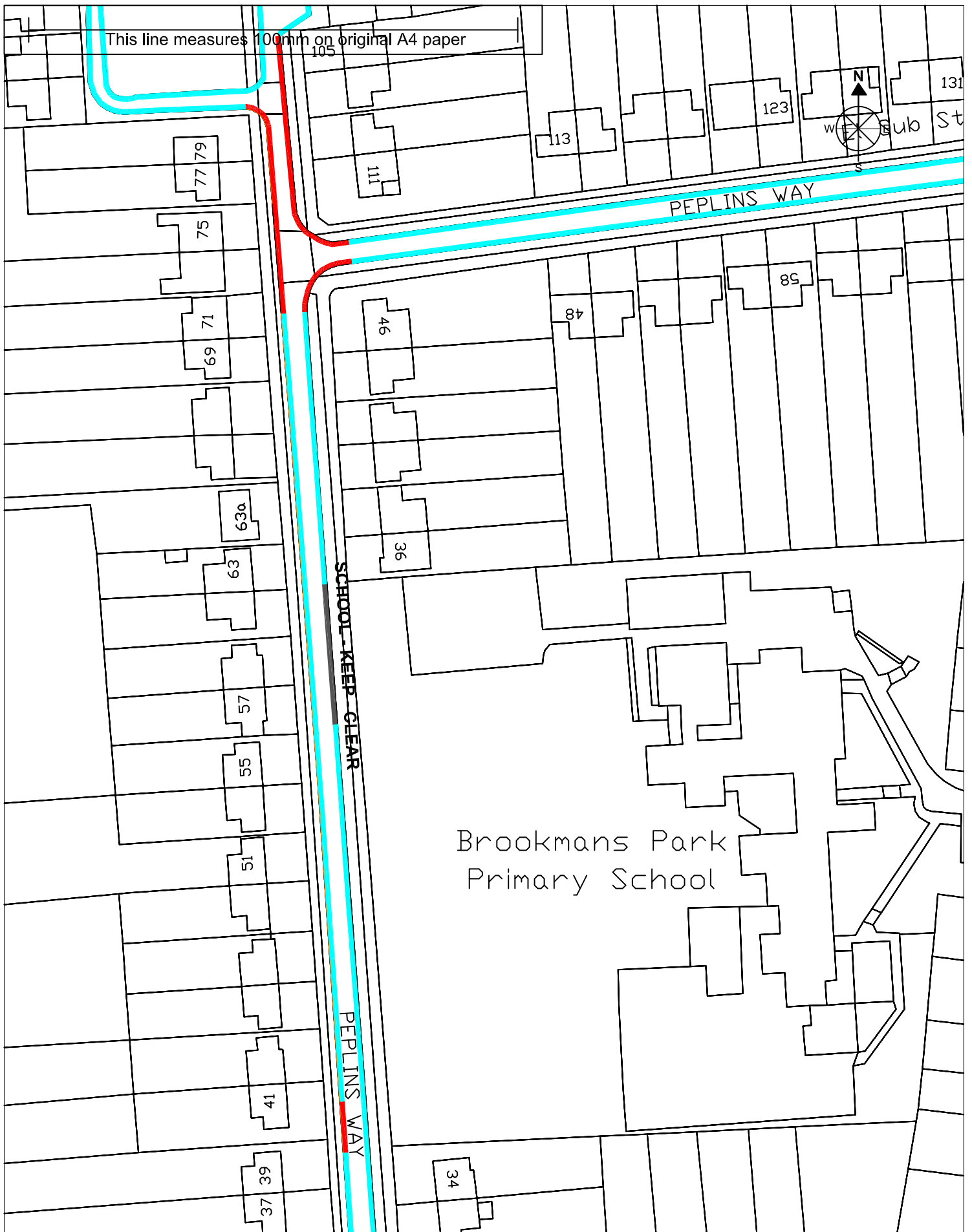
The proposed new restrictions are as follows;

In parts of **Peplins Way, Brookmans Park – Permit Area D 03**

1. No waiting at any time
2. Permit parking places Monday to Friday, 10am – 11am

Consultation has been carried out with local residents, Hertfordshire County Council, Hertfordshire Constabulary, Fire and Ambulance Services and local Councillors representing the area.
