### STATEMENT OF REASONS

# THE HERTFORDSHIRE (HERNS LANE, DANIELLS AND APPLETREE WAY, WELWYN GARDEN CITY) (RESTRICTION OF WAITING) ORDER 2017

Hertfordshire County Council is proposing to improve road safety by implementing new waiting restrictions in Welwyn Garden City.

The proposals will comprise of -

'No waiting at any time' restrictions on parts of Herns Lane, Daniells and Appletree Way.

The restrictions are proposed after receiving reports from the Police that people are parking in too close a proximity to the signalised junction during peak times, which is creating a safety issue. Following Police consultation with HCC Safety Engineering, it identified a requirement for restrictions to be implemented through a TRO. The proposed restrictions have also been recommended throughout the junction in the Stage 3 Road Safety Audit.

Therefore, it appears to the Highway Authority that it is necessary and expedient to make an Order in the interests of; avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, facilitating the passage on the road or any other road of any class of traffic (including pedestrians).

The proposal has been subject to consultation with local and County Councillors representing the area and Welwyn Hatfield Council. The local Police, Ambulance, Fire and Rescue Services, Hertfordshire County Council Passenger Transport Unit, Frederic Osborn School, local businesses and residents have also been consulted.

## THE HERTFORDSHIRE (HERNS LANE, DANIELLS AND APPLETREE WAY, WELWYN GARDEN CITY) (RESTRICTION OF WAITING) ORDER 2017

The Hertfordshire County Council in exercise of their powers under Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

- This Order may be cited as "The Hertfordshire (Herns Lane, Daniells and Appletree Way, Welwyn Garden City) (Restriction of Waiting) Order 2017" and shall come into effect on Monday 25 June 2018.
- Save as provided in Articles 3, 4 and 5 of this Order no person shall cause or permit any vehicle to wait at any time in those lengths of Herns Lane, Daniells and Appletree Way, Welwyn Garden City as specified in the Schedule to this Order.
- 3. (1) Nothing in Article 2 of this Order applies to the lengths of road restricted by that Article (which said lengths of road are referred to in this Article as "the restricted area") in relation to –
  - (a) a vehicle being used for Fire and Rescue, Ambulance or Police purposes.
  - (b) anything done with the permission of or at the direction of a Police Constable in uniform; or with permission of a Civil Enforcement Officer as defined by the Traffic Management Act 2004 and appointed by Welwyn Hatfield Council.
  - (c) a vehicle which is prevented from proceeding by circumstances beyond the drivers control or which has stopped in order to avoid injury or damage to persons or property or when required to do so by law;
  - (d) a vehicle which is stationary in order that it may be used for one or more of the purposes specified in sub-Article (2) of this Article and which cannot reasonably be used for such a purpose without stopping in the restricted area;
  - (e) a marked vehicle which, whilst used by a universal service provider in the course of the provision of a universal postal service, is stationary only for so long as may be reasonably necessary for postal packets to be delivered or collected;

In this Article -

The expressions "universal service provider", "provision of a universal postal Service" and "postal packet" shall bear the same meanings as in Section 65 of the Postal Services Act 2011.

- (2) The "purposes" referred to in sub-Article (1)(d) of this Article are
  - (a) any operation involving building, demolition or excavation;
  - (b) the removal of any obstruction to traffic;
  - (c) the maintenance, improvement or reconstruction of a road;
  - (d) constructing, improving, maintaining, or cleaning of any street furniture; or
  - (e) the laying, erection, alteration, repair or cleaning of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus kept or installed for the purposes of a telecommunications code system or of any other telecommunications apparatus lawfully kept installed in any position.

- 4. Nothing in Article 2 of this Order applies to the lengths of road restricted by that Article (which said lengths of road are referred to in this Article as "the restricted area") so as to render it unlawful to cause or permit any vehicle to wait only for so long as may be reasonably necessary –
  - (a) to enable goods to be loaded on or unloaded from the vehicle from or to premises adjacent to the restricted area; or
  - (b) to enable a passenger to board or alight and to load and unload any luggage.
- 5. (1) Nothing in Article 2 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc, to wait at any time in the lengths of road specified in the Schedule of this Order for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same length of road).
  - (2) In this Article -

"disabled person's vehicle" has the same meaning as in Section 142(1) of the Act of 1984;

"disabled person's badge" has the same meaning as given in Regulation 3(1) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000

"parking disc" has the same meaning as given in Regulation 8(5) of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000; and

"relevant position" has the same meaning as given in Regulation 4 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000

- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 7. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

#### **SCHEDULE**

### <u>lengths of Herns Lane, Daniells and Appletree Way, Welwyn Garden City – no waiting at any time</u>

- Herns Lane (a) from a point in line with the projected south west kerbline of Daniells south (north west side) westwards for approximately 53 metres to a point 15.5 metres south west of a point in line with the south west boundary of 1 Daniells.
  - (b) from a point in line with the projected north east kerbline of Daniells north eastwards for approximately 33 metres to a point 2 metres north east of a point in line with the boundary between 21 and 23 Herns Lane.
- (south east side)(a) from a point in line with the projected south west kerbline of Appletree Way south westwards for approximately 75 metres to a point 36 metres south west of a point in line with the south west boundary of 1 Daniells.
  - (b) from a point in line with the projected north east kerbline of Appletree Way north eastwards for approximately 60 metres to a point 2.5 metres north east of a point in line with the boundary between 27 and 29 Herns Lane.

Daniells from a point in line with the projected north west kerbline of Herns Lane north (north east side) westwards for approximately 45 metres to a point 9 metres north west of a point in line with the boundary between 16 and 18 Daniells.

outh west side) from a point in line with the projected north west kerbline of Herns Lane north westwards for approximately 49 metres to a point 2 metres north west of a point in line with the boundary between 11 and 15 Daniells.

Appletree Way (both sides)

from a point in line with the projected south east kerbline of Herns Lane south eastwards for 48 metres.
