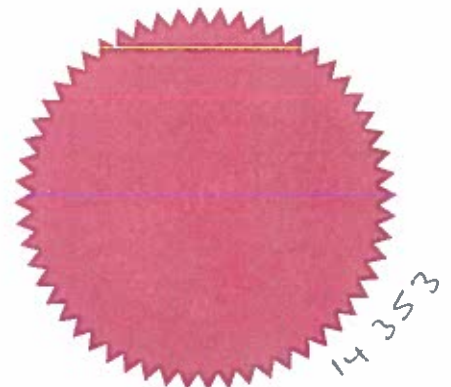
WEST BERKSHIRE DISTRICT COUNCIL in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2) and 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and all relevant powers under Part 6 of the Traffic Management Act 2004 and all enabling powers in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1999 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act **HEREBY MAKES** the following Order which amends and varies **WEST BERKSHIRE DISTRICT COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING, PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) ORDER 2009** ("the Principal Order")

Commencement and Citation

1. This amendment Order shall come into operation on the 22nd day of January 2016 and may be cited as **WEST BERKSHIRE DISTRICT COUNCIL (PROHIBITION AN RESTRICTION OF WAITING AND LOADING, PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) Order 2009 (AMENDMENT NO 20) ORDER 2016**
2. In this Amendment Order except where the context otherwise requires "the Principal Order" shall mean **WEST BERKSHIRE DISTRICT COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING, PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) ORDER 2009**
3. Any reference in this Amendment Order to any enactment shall be construed as reference to that enactment as amended by any subsequent enactment
4. The Interpretation Act 1978 or any replacing Act shall apply for the interpretation of this Order as it applies for the interpretation of any Act of Parliament
5. The Principal Order is hereby amended by the inclusion of the definitions as set out in the Schedule attached to this Order
6. Schedule 2 of the Principal Order is hereby amended by the revision of the following Plans: **AL73, AL75 AND AN76**

SCHEDULE:

1. This Order will amend Article 2 of the Consolidated Order 2009 by the inclusion of the following definitions:

"Car Club" means organised scheme operated by or on behalf of a contractor authorised by the Council.

"Car Club vehicle" means a shared use vehicle of a type approved by the council and available for hire for a specified period by Car Club members and being used within an organised scheme operated by or on behalf of a contractor authorised by the Council.

"Car Club parking place" means a parking place designed for use by Car Club vehicles displaying the relevant identification issued and/or approved by the Council and authorised by sign diagram 660.8.

"Electric Vehicle" means a Plug-in Electric Vehicle or a Plug-in Hybrid Electric Vehicle which uses rechargeable batteries or another energy storage device that can be restored to full charge by connecting to a recharging point

"Electric Vehicle parking place" means a parking place designed for use by Electric Vehicles in order to recharge their supply by using a recharging point and authorised by sign diagram 660.9

"Recharging point" means a device designed for the recharging of an Electrical Vehicle.

"Relevant identification" means a badge or other means of identification issued and/or approved by the Council indicating that a vehicle on which it is displayed is provided by or on behalf of a Car Club and may be validly left in a Car Club parking place

"Virtual Permit" means a permit issued electronically under the provisions of Article 30

2. This Order will amend Article 9(4) and 17(2) by the inclusion of "or has a recorded virtual permit" after "a valid permit"
3. This Order will amend Article 10(4) by the inclusion of ", including Car Club vehicles and electric vehicles" after "authorised to be used as parking places for vehicles"
4. This Order will amend Article 17(1) by the deletion of reference to Article 10(1)
5. The Order will amend PART VI header by the inclusion of "Car Club parking place, electric vehicle parking place," after "refers to a parking place"
6. This Order will amend Article 29(5) by the deletion of "place" after "parking place"
7. This Order will amend Article 34 by the inclusion of "or recorded electronically by the Council as a virtual permit" after "in writing"

8. This Order will amend Article 35 by the inclusion of "Except where a vehicle has been issued a virtual permit," before "At all times"
9. This Order will amend Article 38(6) by the inclusion of "or virtual permit" after "permit" and "or where a virtual permit has been issued that virtual permit will be removed from the electronic register" after "within 48 hours of the receipt of the aforementioned notice"
10. This Order will amend Article 39(1)(a) and (b) by the inclusion of "or virtual permit" after "permit" and "or where a virtual permit has been issued that virtual permit will be removed from the electronic register" after "surrendered to the Council"
11. The Order will amend Article 41(1) by the inclusion of "Car Club parking place, electric vehicle parking place," after "left in a parking place"
