

**WEST BERKSHIRE DISTRICT COUNCIL (OFF STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2009 (CORN EXCHANGE (BEAR LANE)) AND (CENTRAL CAR PARK NEWBURY) AMENDMENT NO 9) ORDER 2016**

WEST BERKSHIRE DISTRICT COUNCIL in exercise of its powers under Sections 32 and 35 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and all relevant powers under Part 6 of the Traffic Management Act 2004 and all enabling powers in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act **HEREBY MAKES** the following Order which amends or varies **WEST BERKSHIRE DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2009** ("the Principal Order")

**Commencement and Citation**

1. This amendment Order shall come into operation on the 23rd day of September 2016 and may be cited as **WEST BERKSHIRE DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2009 (CORN EXCHANGE (BEAR LANE)) AND (CENTRAL CAR PARK NEWBURY (AMENDMENT No 9) ORDER 2016**
2. In this Amendment Order except where the context otherwise requires "The Principal Order" shall mean **WEST BERKSHIRE DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2009**
3. Any reference in this amendment Order to any enactment shall be construed as reference to that enactment as amended by any subsequent enactment
4. The Interpretation Act 1978 or any replacing Act shall apply for the interpretation of this Order as it applies for the interpretation of any Act of Parliament
5. The Principal Order is hereby amended under the Schedule but only as far as it relates to the addition of the Central Car Park Newbury as a pay and display long stay car park and its removal as a Pay on Foot car park as described in Schedule 1 and in respect of the removal of Corn Exchange (Bear Lane) as a Pay and Display short stay car park and its addition as a Pay on Foot car park and the addition of new charging bands as described in Schedule 2 in all other respects the Principal Order remains the same
