


## **Key for Waiting Restrictions**

#### (LANCING: UPPER BOUNDSTONE LANE AND ADJOINING ROADS AMENDMENT) ORDER 2019

West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-


