


LOCATION OF WAITING RESTRICTIONS

(FERRING: MARINE DRIVE AMENDMENT) ORDER 2016

West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the Fifth day of September 2016 and may be cited as "West Sussex County Council ((Arun District) (Parking Places & Traffic Regulation) (Consolidation) Order 2010) (Ferring: Marine Drive Amendment) Order 2016".
- 2. The West Sussex County Council (Arun District) (Parking Places & Traffic Regulation) (Consolidation) Order 2010 is hereby amended by the insertion of the following interpretation into Article 3.1:
 - "motor caravan" means a motor vehicle which is constructed or adapted for the carriage of passengers and their effects and which contains, as permanently installed equipment, the facilities which are reasonably necessary for enabling the vehicle to provide mobile living accommodation for its users.
- 3. The "West Sussex County Council (Arun District) (Parking Places & Traffic Regulation) (Consolidation) Order 2010" is hereby amended by the replacement of the plan specified in the First Schedule to this Order, with the plan specified in the Second Schedule, attached hereto.
