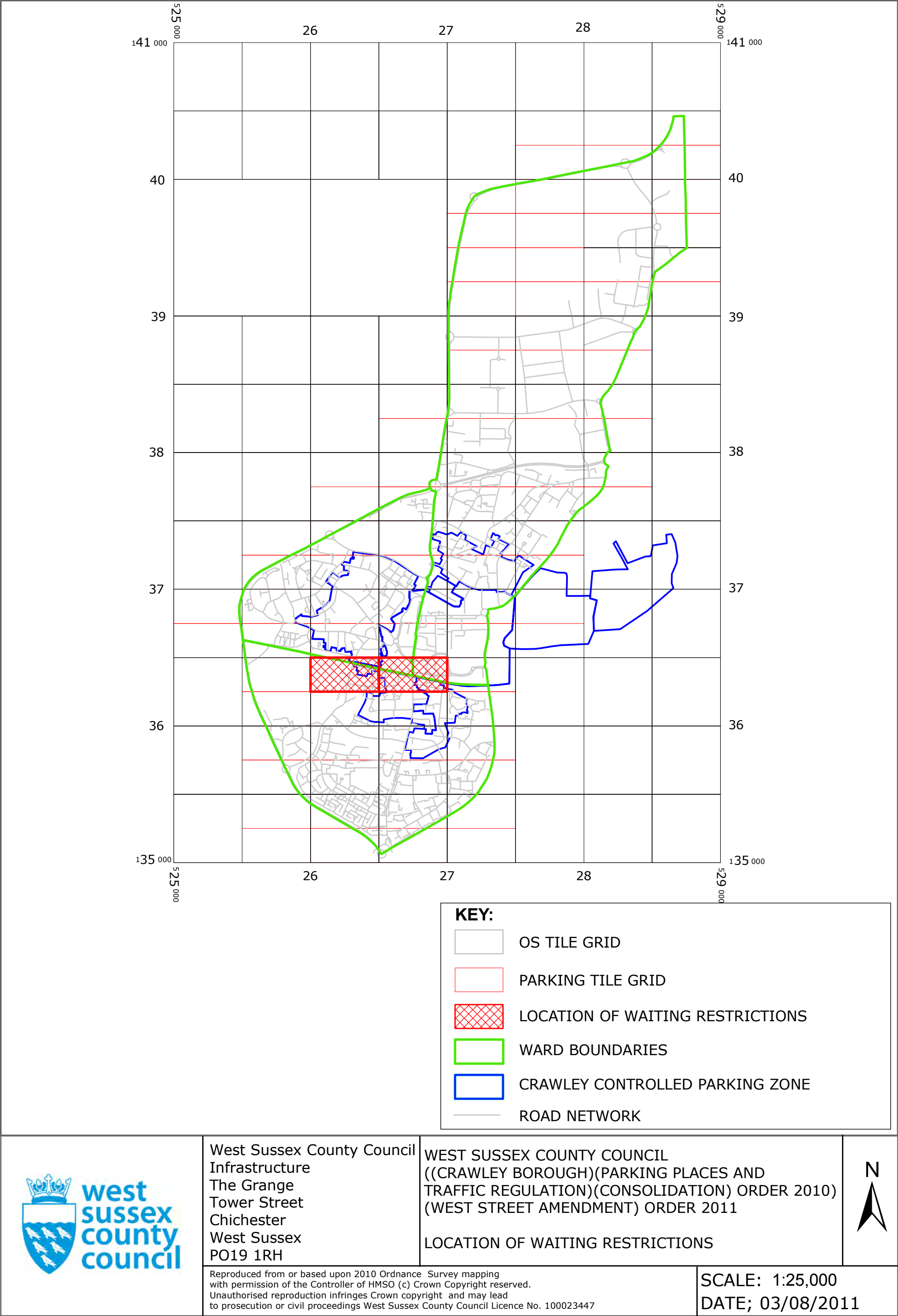



NORTHGATE, SOUTHGATE AND WEST GREEN: LOCATIONS OF WAITING RESTRICTIONS




Key for Waiting Restrictions




West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 "the Act" as amended and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

THIRD RC

1. This Order shall come into operation on the first day of August 2011 and may be cited as "West Sussex County Council ((Crawley Borough) (Parking Places and Traffic Regulation) (Consolidation) Order 2010) (West Street Amendment) Order 2011."
2. The "West Sussex County Council (Crawley Borough) (Parking Places and Traffic Regulation) (Consolidation) Order 2010" is hereby amended by the deletion from it of the plans specified in the First Schedule to this Order and the substitution of the plans attached in the Second Schedule to this Order.
