


## (PULBOROUGH: NEW PLACE ROAD & LONDON ROAD AMENDMENT) **ORDER 2011**

West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order shall come into operation on the Fifth day of December 2011 and may be cited as "West Sussex County Council ((Horsham District) (Parking Places and Traffic Regulation) (Consolidation No. 2) Order 2006) (New Place Road & London Road Amendment) Order 2011".
- 2. The "West Sussex County Council (Horsham District) (Parking Places and Traffic Regulation) (Consolidation No. 2) Order 2006" is hereby amended by the replacement of the plan specified in the First Schedule to this Order, with the plan specified in the Second Schedule, attached hereto.
