




#### **Key for Waiting Restrictions**


#### **Shared Residents Parking & Charged On-street Parking**

West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 "the Act" as amended and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the 26<sup>th</sup> day of April 2012 and may be cited as "West Sussex County Council ((Horsham District) (Parking Places and Traffic Regulation) (Consolidation No. 2) Order 2006) (East Street Experimental Amendment) Order 2012."




