



The plans in this schedule are based upon grid references of the Ordnance Survey National Grid defined by the OSGB 36 triangulation.

West Sussex County Council in exercise of their powers under Sections 1 (1) 2 (1) and (2), 4 (2), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order shall come into operation on the Twenty Fourth day of September 2012 and may be cited as "West Sussex County Council ((Horsham District) (Parking Places & Traffic Regulation) (Consolidation No.2) Order 2006) (Steyning: Shooting Field Amendment) Order 2011".




