THE BOROUGH OF WORTHING (OFF STREET PARKING PLACES) CONSOLIDATION ORDER 2007

(Amendment No.2) ORDER 2010

The Council of The Borough of Worthing (hereinafter referred to as "the Council") in exercise of its powers under Section 35 of the Road Traffic Regulation Act, 1984, as amended ("the Act") and of all other enabling powers, with the consent of West Sussex County Council and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

Commencement and Citation

1. The Order shall come into operation on 1 January 2010 and may be cited as "The Borough of Worthing (Off Street Parking Places) Consolidation Order 2007 (Amendment No. 2) Order 2010.

Effect of the Order

- 1. The Borough of Worthing (Off Street Parking Places) Consolidation Order 2007 ("the Order") shall have effect as though:
- A. a further definition was added to the Order as follows:
- "fast park" means a park and pay by phone scheme, which allows a driver to make daily payments to park at designated car parks. A nominal administration fee is charged per booking. A driver can make daily payments for up to a month in advance in a block.
- B. a further definition was added to the Order as follows:
- "parking disc" means a device (a clock) which is i) 125 millimetres square and coloured blue and ii) has been issued by a local authority and has not ceased to be valid and iii) is capable of showing the quarter hour period from when the vehicle is first parked and throughout the period of parking.
- C. The definition of "relevant position" was amended with the following:
- (b) in respect of a vehicle displaying a ticket, season ticket, weekly ticket, permit or indication of participation in a scheme of approved method of payment, including fast park.

D. Paragraph 19 of the Order, the first sentence, was amended with the following:

On obtaining a pay and display ticket, the driver of the vehicle shall, except where the driver is part of the Fast Park scheme,

- E. Paragraph 37 of the Order was amended with the addition of:
- (iv) A vehicle which displays in the relevant position a valid disabled person's badge and a parking disc which clearly marks the quarter period during which the exempted waiting began within a car park with a maximum stay period provision.
- F. The existing paragraph 57 of the Order was deleted and replaced with:

Full payment of the Penalty Charge Notice (PCN) must be received not later than the last day of the period of 28 days beginning with the date on which the PCN was served. If the PCN is not paid before the end of the period of 28 days, beginning with the date on which the PCN was served, the Council may serve a Notice to Owner on the registered keeper. If the PCN is paid not later then the last day of the period of 14 days (refers to first 14 days from when the PCN was served) the amount of any applicable discount applies.
