

**WEST BERKSHIRE DISTRICT COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING, PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (AMENDMENT NO 7) ORDER 2010**

**WEST BERKSHIRE DISTRICT COUNCIL** in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2) and 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and all relevant powers under Part 6 of the Traffic Management Act 2004 and all enabling powers in accordance with the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act **HEREBY MAKES** the following Order which amends or varies **WEST BERKSHIRE DISTRICT COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING, PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) ORDER 2009** ("the Principal Order")

**Commencement and Citation**

1. This amendment Order shall come into operation on the 30th day of July 2010 and may be cited as **WEST BERKSHIRE DISTRICT COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING, PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (AMENDMENT NO 7) ORDER 2010**
2. In this Amendment Order except where the context otherwise requires "The Principal Order" shall mean **WEST BERKSHIRE DISTRICT COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING, PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) ORDER 2009**
3. Any reference in this amendment Order to any enactment shall be construed as reference to that enactment as amended by any subsequent enactment
4. The Interpretation Act 1978 or any replacing Act shall apply for the interpretation of this Order as it applies for the interpretation of any Act of Parliament
5. The Principal Order is hereby amended by the inclusion under Schedule 1 – Streets for the Issue of Permits

  2. The Arcade
