# TAVISTOCK TOWN COUNCIL (CIVIL ENFORCEMENT OFF-STREET PARKING PLACES) CONSOLIDATION ORDER 2008

TAVISTOCK TOWN COUNCIL in exercise of its powers under Section 57 and 59 of the Road Traffic Regulation Act 1984, Regulation 21 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996, and the Traffic Management Act 2004 and all other enabling powers and with the consent of Devon County Council HEREBY MAKES THE FOLLOWING ORDER:

## **Operative Provisions**

- This Order shall come into operation on the 5<sup>th</sup> May 2008 and may be cited as the Tavistock Town Council (Civil Enforcement Off-Street Parking Places) Consolidation 1. Order 2008
- The Tavistock Town Council's previous Off-Street Parking Places Order entitled The Tavistock Town Council (Off-Street Parking Places) Order 2002 2. ("the Car Park Order") is hereby revoked except so far as provided for below
- The Car Park Order is hereby re-enacted except in relation to any provisions which conflict with the new enforcement powers under the Traffic Management Act 2004 3. and regulations made thereunder as a consequence of the designation of the Council's area as a civil enforcement area as provided for by the Civil Enforcement of Parking Contraventions (County of Devon) Designation Order 2008

#### **New Provisions**

4.

Civil Enforcement Officer - has the same meaning as in section 76 of the Traffic Management Act

Penalty Charge – has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007

Penalty Charge Notice - has the same meaning as in the Civil Enforcement of Parking Contraventions (England) General Regulations 2007

- There will no longer be a requirement for the driver of the vehicle to pay a standard 5. charge or reduced standard charge
- A Penalty Charge will be payable by the driver or the owner of the vehicle for not complying with the provisions of the Car Park Order for the use of the car park. 6. These provisions are now called parking contraventions and are listed in the Schedule to this Order.
- All enforcement of parking contraventions will be carried out by Civil Enforcement 7. Officers

- Enforcement of Penalty Charges shall be carried out in accordance with the 8. provisions of the Civil Enforcement of Parking Contraventions (England) General Regulations 2007
- Any appeals and representations following the issue of a Penalty Charge Notice 9 shall be conducted in accordance with the Civil Enforcement of Parking Contraventions (England) Representations and Appeals Regulations 2007
- In the event of a conflict between the Car Park Order and the Regulations, the 10. Regulations shall take precedence.
