THE ADUR DISTRICT (OFF STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2011. (AMENDMENT No 1) ORDER 2016

Notice is hereby given of the District Council of Adur making Amendment No. 1 to The Adur District (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2011. The Amendment shall come into effect on 2 May 2016.

The general effect of the Order is:

- To introduce the sale of annual Season tickets at Ropetackle Car Park, Shoreham
- To introduce Pay and Display Charges and the sale of monthly and quarterly Season tickets at Ham Road Car Park, Shoreham
- Remove Ship Street Car Park from the Order

A copy of the Order and the documents giving more detailed particulars of the Order can be inspected during normal office hours at Portland House, Richmond Road, Worthing, West Sussex, BN11 1HS. Details are also available on the Council's internet.

If any person wishes to question the validity of the Order or any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of the Act or any instrument made under the Act has not been complied with, that person should within 6 weeks from the date on which the Order is made apply for the purpose to the High Court.

**The Adur District (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2011.(Amendment No. 1) Order 2016**

The Council of the District of Adur (hereinafter called the "Council") in exercise of its powers under Section 35 of the Road Traffic Regulations Act 1984, as amended ("the Act") and of all other enabling powers, and after consultation with West Sussex County Council, the Chief Officer of Police and other relevant bodies in accordance with Part III of Schedule 9 of the Act hereby make the following Order;

**Commencement and Citation**

This Order shall come into operation on 2 May 2016 and may be cited as The Adur District (Off Street Parking Places) (Civil Enforcement and Consolidation) Order 2011 (Amendment No. 1) Order 2016.

**Effect of the Order**

The Order shall have the effect as follows;

Amend the Schedule of the 2011 Order as follows:

- To introduce Season tickets at Ropetackle Car Park at the cost of £350.00 per annum
- To introduce Pay and Display Charges and Season tickets at Ham Road Car Park
- To remove Ship Street Car Park from the Schedule and the Order
