

The Adur District (Off- Street Parking Places) (Civil Enforcement and Consolidation) Order 2011. Minor Order No. 1 2016

The Council of the District of Adur in exercise of its powers under Section 35 of the Road Traffic Regulations Act 1984, as amended, and of all other enabling powers hereby make the following Order;

Commencement and Citation

This Minor Order shall come into operation on 15 July 2016 and may be cited as The Adur District (Off- Street Parking Places) (Civil Enforcement and Consolidation) Order 2011. Minor Order No. 1 2016.

Effect of the Order

The Minor Order shall have the effect on that there will no longer be the facility to purchase quarterly season tickets at the Ham Road Car Park and for clarification season tickets will only be able to be purchased on a monthly basis. Therefore in the Schedule to the 2011 Order in the part relating to Ham Road Car Park the words "£100.00 Quarterly" are deleted.
