

WEST SUSSEX COUNTY COUNCIL
((MID SUSSEX DISTRICT) (PARKING PLACES & TRAFFIC REGULATION)
(CONSOLIDATION NO.2) ORDER 2006)
(PAY BY PHONE MINOR) ORDER 2023

West Sussex County Council in exercise of their powers under Sections 32, 35 and 39(6) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the Second day of October 2023 and may be cited as "West Sussex County Council ((Mid Sussex District) (Parking Places & Traffic Regulation) (Consolidation No.2) Order 2006) (Pay By Phone Minor) Order 2023."
2. The "West Sussex County Council ((Mid Sussex District) (Parking Places & Traffic Regulation) (Consolidation No.2) Order 2006" is hereby amended by the insertion into it of the Articles in the First Schedule to this Order.

FIRST SCHEDULE
Articles to be inserted

1. Article 3.1 Interpretation

"expiry time" is the time indicated on the parking ticket or the time indicated by the confirmation given by the pay by phone technology service and is the time by which the vehicle must leave the parking place;

"pay by phone technology" means a park and pay by phone scheme that allows a driver to make daily "pay by phone payments" to park facilitated by mobile phone, by SMS, smartphone applications, online or by telephone;

2. Article 35

- 35.2 Those parking places shown in the Order plans as Pay & Display parking places may also be used where the driver is part of the pay by phone technology scheme and has paid for parking that vehicle in that parking place at the level of charge and for the period required in accordance with the charges specified in this Order.

3. Article 36

- 36.3 If at any time while a vehicle is parked in a parking place no parking ticket is displayed on that vehicle and no record of pay by phone payment has been made, it shall be deemed that that charge has not been paid.

4. Article 37

- 37.3 A vehicle must leave a parking place by the expiry time indicated on the parking ticket or the time indicated by the confirmation given by the pay by phone technology service.


5. Article 37

- 37.4 The expiry of the period when the appropriate charge has been paid is when the time on the clock of the issuing ticket machine is later than the expiry time shown on the Pay & Display ticket or when the time recorded on the pay by phone technology system is later than the confirmation given by the pay by phone

technology service.
