

# HAYWARDS HEATH: LOCATIONS OF WAITING RESTRICTIONS






PARKING TILE GRID

### WEST SUSSEX COUNTY COUNCIL ((MID SUSSEX DISTRICT) (PARKING PLACES AND TRAFFIC REGULATION) (CONSOLIDATION NO.2) ORDER 2006) (TEMPORARY BOLNORE ROAD) ORDER 2008

WHEREAS the County Council of West Sussex ("the Council") being the traffic authority for BOLNORE ROAD, Haywards Heath is satisfied that vehicular access to the length of the said road as specified in the Schedule to this Order should be prohibited to allow the freeflow of traffic on the highway and the safe movement of construction vehicles entering Bolnore Village site.

NOW THEREFORE, the Council in exercise of their powers under Section 15 (2) of the Road Traffic Regulation Act 1984 as amended, and of all other powers enabling them in that behalf make the following Order:-

- This Order shall come into operation on the twenty ninth day of September 2008 and may be cited as "West Sussex County Council ((Mid Sussex District) (Parking Places and Traffic Regulation) (Consolidation No. 2) Order 2006) (Temporary Bolnore Road) Order 2008."
- 2. The "West Sussex County Council (Mid Sussex District) (Parking Places and Traffic Regulation) (Consolidation No.2) Order 2006" is hereby amended by the temporary suspension from it of the plan specified in the First Schedule to this Order; the temporary substitution of the plan attached in the Second Schedule to this Order and, the temporary insertion of the plans attached in the Third Schedule to this Order.
