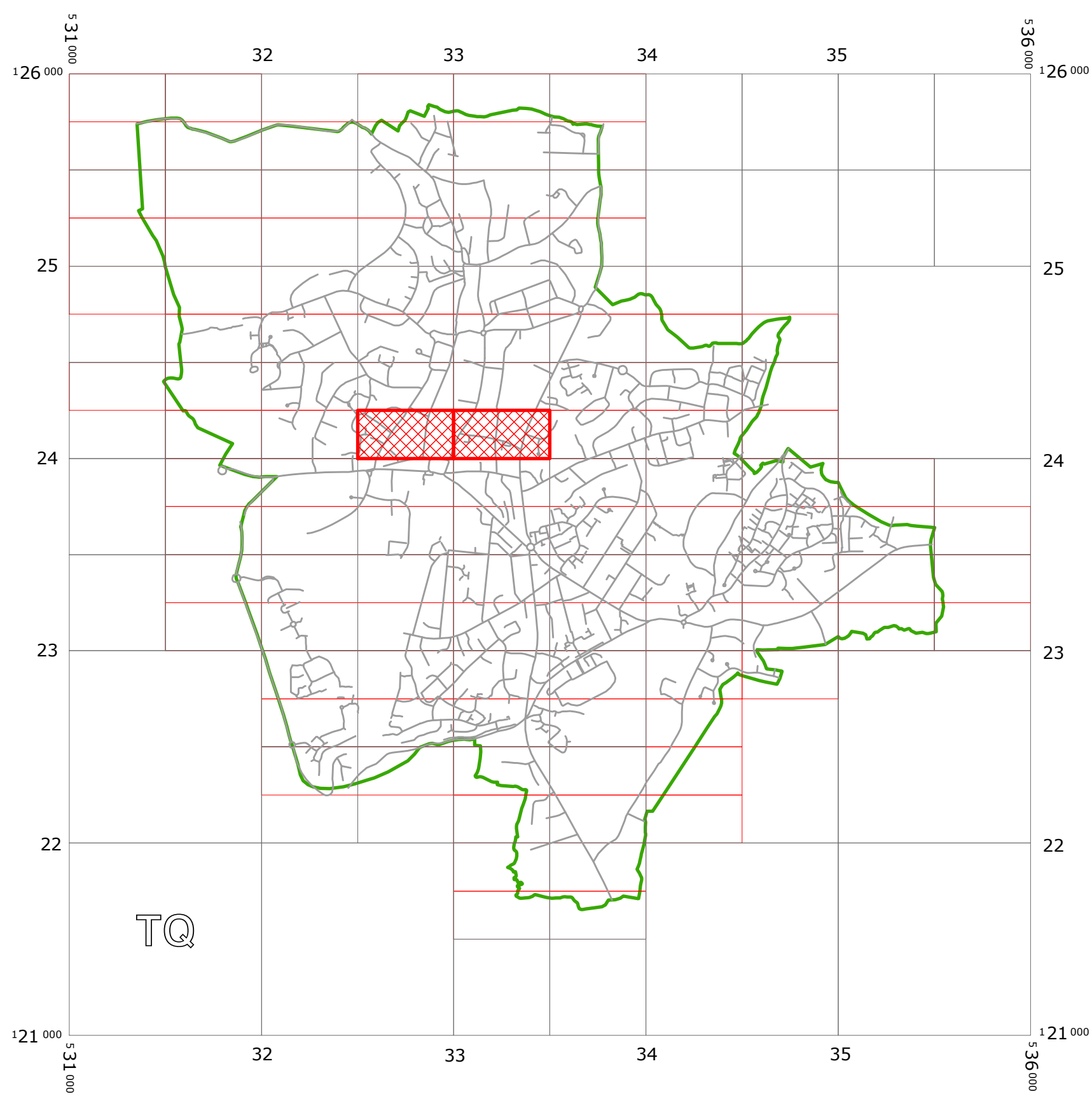



Key for Waiting Restrictions



WEST SUSSEX COUNTY COUNCIL
(HAYWARDS HEATH: THE BROADWAY)
(EXPERIMENTAL SATURDAY MARKETS) ORDER 2011

West Sussex County Council in exercise of their powers under Sections 9 and 10 (2) of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the 3rd day of September 2011 and may be cited as "West Sussex County Council (Haywards Heath: The Broadway) (Experimental Saturday Markets) Order 2011."
2. No person shall cause or permit any vehicle to be driven in the length of road specified in the Schedule to this Order between 8am and 3pm on any Saturday.
3. Nothing in Article 2 shall apply to any vehicle used in connection with the Saturday Market, or being driven by permission of the organizers of the Saturday Market.
4. Nothing in Article 2 shall apply to any vehicle being driven for the purpose of accessing premises located on the length of road specified in the Schedule to this Order.
5. Nothing in Article 2 shall apply to any vehicle being used by the Police, Ambulance Service or Fire Brigade in the event of an emergency.
6. During the operative period of this Order the West Sussex County Council (Mid Sussex District) (Parking Places & Traffic Regulation) (Consolidation No.2) Order 2006 is hereby suspended insofar as it specifies the parking restriction on the existing limited waiting parking bays on both sides of The Broadway, between its junction with Muster Green North and Heath Road as shown on Tile Numbers TQ3324SWS and TQ3224SES, attached to that Order.
7. During the operative period of this Order the restriction on the parking bays specified in Article 6 shall be: No Waiting between 8am and 3pm on Saturdays, Waiting Limited to Two Hours, No Return Within 1 Hour between 8am and 6pm Monday to Friday.
8. The terms and conditions of use of the bays specified in Article 6 of this Order shall be the same as those set out in the West Sussex County Council (Mid Sussex District) (Parking Places & Traffic Regulation) Consolidation no.2) Order 2006.
9. If it appears to the County Council essential in the interests of the expeditious, convenient and safe movement of traffic, or the provision of suitable adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by the Order runs, they may after -
 - (a) consulting with the Chief Officer of Police, and
 - (b) giving such public notice as the Secretary of State may direct,
 make modifications or suspend the Order or any provision contained therein.

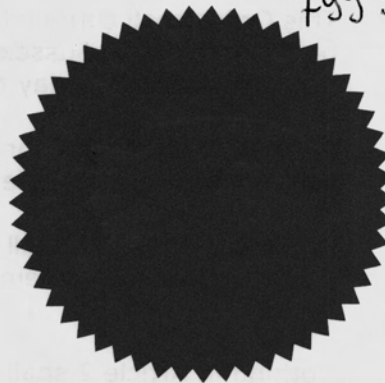

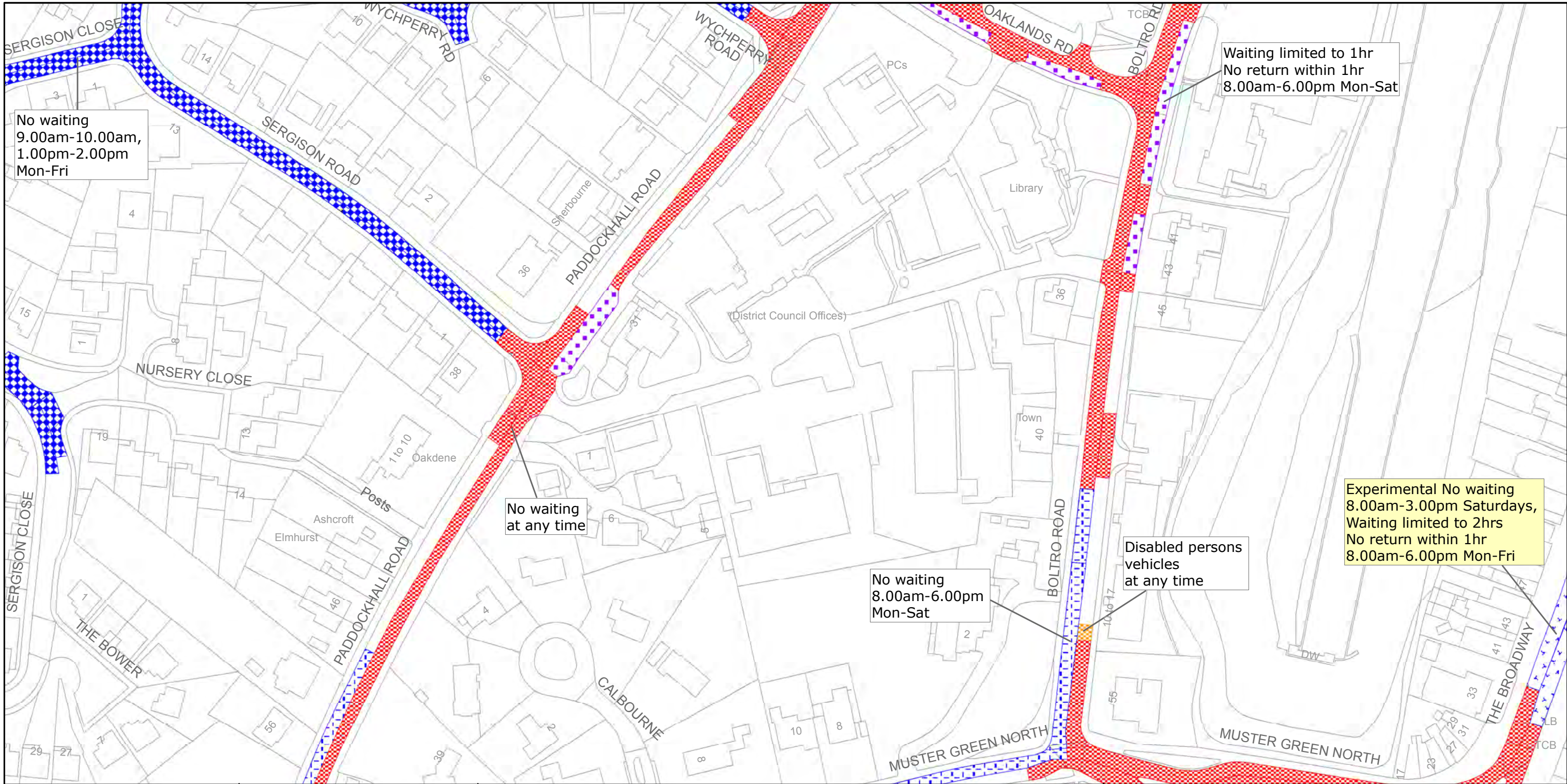

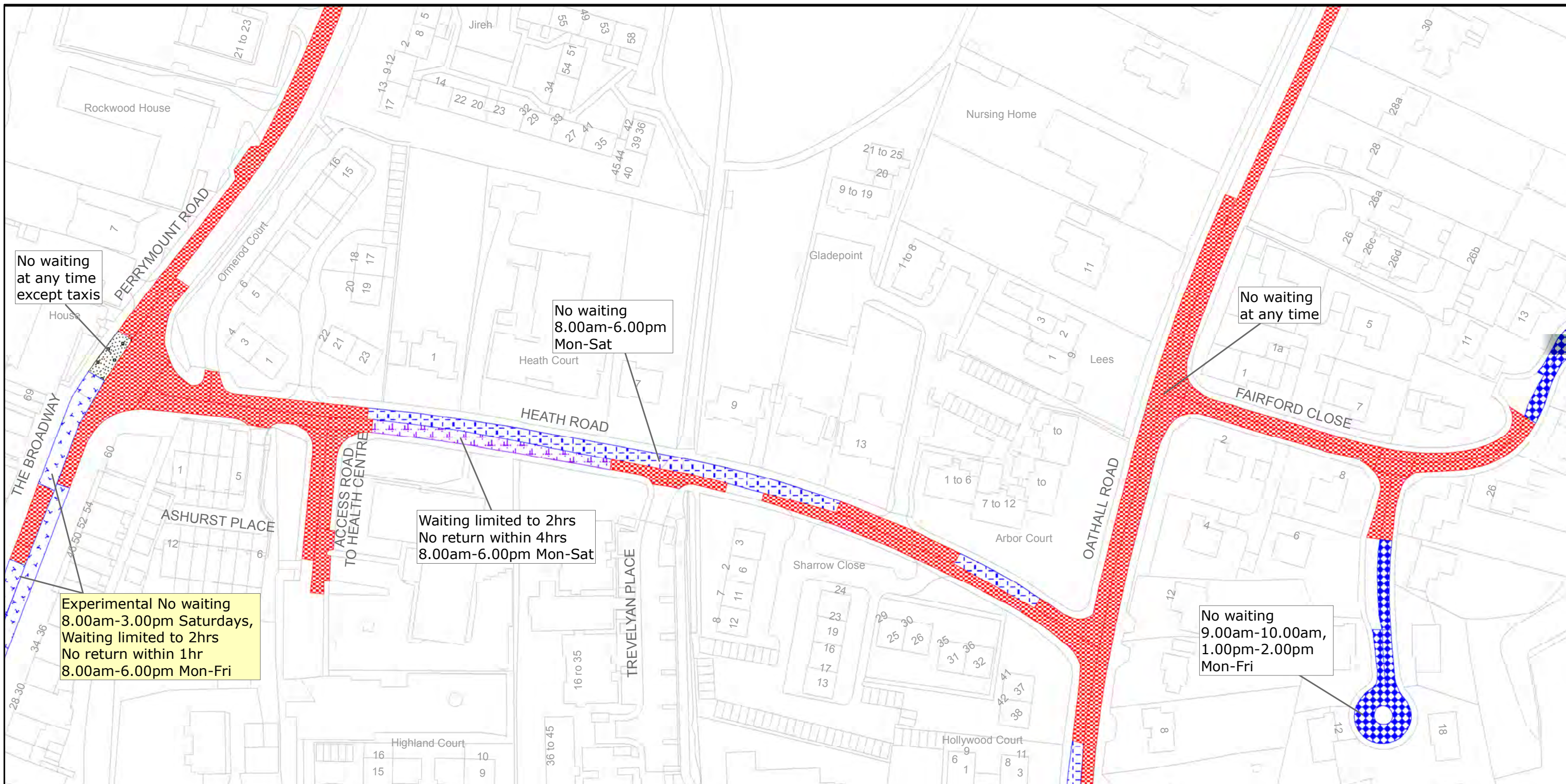
