



WEST SUSSEX COUNTY COUNCIL acting as the local traffic authority for Bolnore Road Haywards Heath and in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended, and of all other enabling powers, hereby makes the following Order:-

- 1. This Order shall come into operation on the 29th day of September 2013 and may be cited as "West Sussex County Council ((Mid Sussex District) (Parking Places and Traffic Regulation) (Consolidation No. 2) Order 2006) (Temporary Bolnore Road) Order 2013."
- 2. Vehicular access to lengths of Bolnore Road should be restricted to protect public safety and comply with specified planning conditions regarding permitted access to the Bolnore Village site during construction.






