**WIGAN BOROUGH(DECriminalISATION OF PARKING)**  
**(WIGAN ROADS NO. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004**  
**(AMENDMENT NO.88) ORDER 2017**

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No.88) Order 2017 and shall come into operation on 31<sup>st</sup> July 2017.
2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
  - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry/entries shall be deleted from Schedule One to the Order:-

ROAD	SIDE	FROM	TO
Highfield Grange Avenue	South	A point 10 metres southwest of its junction with Erradale Crescent	A point 10 metres northeast of its junction with Erradale Crescent
Highfield Grange Avenue	North	A point 10 metres southwest of its junction with Melrose Drive	Point 10 metres northeast of its junction with Melrose Drive
Highfield Grange Avenue	South	A point 10 metres southwest of its junction with Kirkstile Crescent	A point 10 metres northeast of its junction with Kirkstile Crescent
Highfield Grange Avenue	North	A point 15 metres southwest of its junction with Dalton Drive	A point 15 metres northeast of its junction with Dalton Drive
Erradale Crescent	Both	Its junction with Highfield Grange Avenue	A point 10 metres southeast of its junction with Highfield Grange Avenue
Melrose Drive	Both	Its junction with Highfield Grange Avenue	A point 10 metres northwest of its junction with Highfield Grange Avenue
Kirkstile Crescent	Both	Its junction with Highfield Grange Avenue	A point 10 metres southeast of its junction with Highfield Grange Avenue
Dalton Drive	Both	Its junction with Highfeild Grange Avenue	A point 10 metres northwest of its junction with Highfield Grange Avenue

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
