WIGAN BOROUGH(DECRIMINALISATION OF PARKING) (WIGAN ROADS NO. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO.88) ORDER 2017

Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order

- This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No.88) Order 2017 and shall come into operation on 31st July 2017.
- 2. Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) is hereby further amended as follows:-
 - (a) In relation to Schedule One, Prohibition of Waiting at any time, the following entry/entries shall be deleted from Schedule One to the Order:-

Erradale Crescent	Both	Its junction with Highfield Grange Avenue	A point 10 metres southeast of its junction with Highfield Grange Avenue
Melrose Drive	Both	Its junction with Highfield Grange Avenue	A point 10 metres northwest of its junction with Highfield Grange Avenue
Kirkstile Crescent	Both	Its junction with Highfield Grange Avenue	A point 10 metres southeast of its junction with Highfield Grange Avenue
Dalton Drive	Both	Its junction with Highfeild Grange Avenue	A point 10 metres northwest of its junction with Highfield Grange Avenue

3. Save as provided in relation to the above amendments Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 (as amended) shall remain in force.
