THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING) (WIGAN ROADS No.2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004

PART 1

The Wigan Borough Council ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 47 and 49 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and the Road Traffic Act 1991 ("the 1991 Act") and of all other powers enabling it in that behalf hereby makes the following Order:-

- 1. This Order may be cited as "The Wigan Borough (Decriminalisation of Parking)(Wigan Roads No.2) (Traffic Regulation Consolidation) Order 2004 and shall come into operation on 1st July 2004.
- 2. The Council hereby revokes all existing permanent traffic regulation orders (except The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004) made by it or any predecessor authority empowered to make such an order in respect of all the roads listed in column one of the schedules to this order except and to the extent that any such order creates a moving traffic offence.

DEFINITIONS

3. In this Order:-

"appointment letter" means "an appointment letter issued by the Driving Standards Agency (or any replacement agency or body taking over its functions) advising candidates of the date and time of the Practical Driving Test for which they have applied";

"authorised loading bay" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002.

"bus" has the same meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 2002.

"bus stop area" means any area of carriageway of a road specified in columns 1 to 4 of Schedule 13 to this Order, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagrams 1025.1, 1025.3 or 1025.4 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

"charging hours" means any period specified in Column 5 of the 6th Schedule in respect of which a charge is specified in Article 18;

"disabled driver" means (i) any person driving an invalid carriage or (ii) any person driving an authorised vehicle fitted with a badge issued in accordance with the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"disabled person" means a disabled person of a description presented by Regulation 5 of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"disabled person's badge" means either

- (i) a badge in the form prescribed by Regulation 11 of The Disabled Persons (Badges for Motor Vehicles)(England) Regulations 2000; or
- (ii) a replacement badge issued in accordance with Regulation 7 of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.

"disabled person's vehicle" has the same meaning as in the Local Authorities Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000 means a vehicle which displays in the relevant position a disabled person's badge issued by any local authority in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 or a badge having effect under those regulations as if it were a disabled persons badge;

"doctors parking place" means any area on a highway designated as a doctors parking place by this Order;

"doctors parking space" means a space in the doctors parking place referred to in columns 1 to 4 of Schedule 8 to this Order which is provided for the leaving of the vehicle:

"doctors permit" means a permit issued under the provisions of Article 66(3) of this Order:

"doctors permit holder" means a person to whom a permit has been issued under the provisions of Article 66(3) of this Order;

"doctors permitted hours", in relation to the doctors parking space, means the period specified in column 6 of Schedule 8 relating to the doctors parking place;

"driver" in relation to a vehicle means the person driving the vehicle at the time it was left in the parking place;

"full registered person" has the same meaning as in Section 55 of the Medical Act 1983;

"goods" includes postal packets of any description and cash over five kilograms in weight or one thousand pounds value; and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"goods vehicle" means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description, and is not drawing a trailer;

"hackney carriage" has the same meaning as in Section 38 of the Town Police Clauses Act 1847;

"initial charge" means the sum defined in column 6 of the 6th Schedule in respect of any particular parking place;

"initial period" means the length of time for which an initial charge has been paid PROVIDED THAT if a greater value of coins are inserted into the ticket machine than the maximum initial charge could be for a parking place then the initial period shall be the maximum stay for the parking place stated in the 6th column of the 6th Schedule;

"moving traffic offence" means a one way street/road, a speed restriction, a prohibition of driving, a weight restriction, a street playground (play street), a prohibition of cycling, a prohibition of right or left turn, a derestricted road, a prohibition of through traffic, a prohibition of U turn, a width restriction, a bus lane, a height restriction or a cycle lane;

"motorcycle" has the same meaning as that in Section 185 of the Road Traffic Act 1988;

"owner" in relation to a vehicle waiting in a parking place, means the person by whom such vehicle is kept and used;

"parking attendant" means a person authorised by or on behalf of the Council to supervise any parking place;

"parking disc" means a device which

- (a) is 125 millimetres square and coloured blue;
- (b) has been issued by a Local Authority and has not ceased to be valid; and
- (c) is capable of showing the quarter-hour period during which a period of waiting has begun;

"parking place" means any length of road in the Borough of Wigan specified in Columns 1 to 4 of the 6th Schedule provided by the Council and designated as a parking place by Article 15 of this Order;

"parking ticket" means a ticket dispensed by a ticket machine on the payment of the initial charge;

"pedal cycle" means a unicycle, bicycle, tricycle, or a cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purpose of the Road Traffic Regulation Act 1984;

"penalty charge" and "reduced penalty charge" means a charge set by the Council under the provisions of section 66 of the 1991 Act which is to be paid to the Council within 28 days beginning with the date of the penalty charge notice, or 14 days in the case of a reduced penalty charge, following the issue of a penalty charge notice;

"penalty charge notice" means a notice issued or served by a parking attendant pursuant to the provisions of section 66 of the 1991 Act containing the particulars therein required;

"permit" means a permit issued under the provisions of Article 30(6) of this Order;

"permit holder" means a person to whom a permit has been issued under the provisions of Article 30(6) of this Order;

"permanent traffic regulation order" means an Order made under Sections 1, 2, 4, 32,

35, 45, 46, 47 or 49 of the Road Traffic Regulation Act 1984;

"public service vehicle" has the meaning given in Section 1 of the Public Passenger Vehicles Act 1981:

"relevant position" means:-

- (i) A vehicle displays a disabled person's badge in the relevant position if:-
 - (a) the badge is exhibited on the dashboard or facia of the vehicle, or
 - (b) where the vehicle is not fitted with a dashboard or facia the badge is exhibited in a conspicuous position on the vehicle,

so that the front of the badge is clearly legible from the outside of the vehicle.

- (ii) A vehicle displays a parking disc in the relevant position if:-
 - (a) the disc is exhibited on the dashboard or facia of the vehicle, or
 - (b) where the vehicle does not have a dashboard or facia, the disc is exhibited in a conspicuous position on the vehicle;

so that, when marked to show the quarter-hour period during which a period of waiting began, that period is clearly legible from the outside of the vehicle

- (iii) A vehicle displays a parking ticket in the relevant position if:
 - in the case of a vehicle fitted with a dashboard or facia panel, the parking ticket is exhibited thereon so that the time shown on the front of the parking ticket is legible from outside the vehicle.

Or

(b) in the case of a vehicle not so fitted, the parking ticket is exhibited in a conspicuous position on the vehicle so that the time shown on the front of the parking ticket is legible from outside the vehicle.

"school entrance marking" means the sides and lengths of roads in the Borough of Wigan specified in columns 164 of Schedule 9 which are marked with the road marking complying with Diagram 642.2 of the Traffic Signs Regulations and General Directions 1994;

- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 5. A reference in this Order to a numbered Article is a reference to the Article having that number in this Order.

PART 2 - PROHIBITION, RESTRICTION AND LIMITED WAITING

- 6. Save as provided in Article 9 no person shall except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant cause or permit a vehicle to wait at any time on the sides and lengths of road specified in columns 1 to 4 of Schedule One to this Order.
- 7. Save as provided in Article 9 no person shall except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant cause or permit a vehicle to wait on the sides and lengths of road specified in columns 1 to 4 of Schedule 2 to this Order during the period of operation specified in column 5 of Schedule 2 to this Order.
- 8. Save as provided in Article 9 of this Order no person shall, except upon the direction of or with the permission of a Police Constable in uniform or of a parking attendant cause or permit a vehicle to wait during the period of operation specified in column 7 of Schedule 3 to this Order on the sides and lengths of road specified in columns 1 to 4 of Schedule 3 to this Order:-
 - (a) for a longer period than that specified in column 5 to Schedule 3 to this Order; or
 - (b) if the vehicle is removed from any length of road specified in this article no person shall cause the vehicle to return and wait on the said length of road within the period specified in column 6 of Schedule 3 to this Order.
- 9. (1) It is not unlawful to cause or permit a vehicle to wait on a side or length of road specified in Schedules 1, 2, 3 or 4 to this Order for so long as may be necessary to enable
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in or in connection with any of the following operations, namely
 - (i) building, engineering or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of such length of road; or
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, such length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telecommunications Act 1984.
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or water companies in pursuance of statutory powers or duties;
 - (d) the vehicle to be used for fire services, ambulance or police purposes or in connection with a funeral provided always that the vehicle being used for fire service, ambulance or police purposes is a liveried vehicle;

- (e) the vehicle to be used in the delivery or collection of postal packets as defined in Section 87 of the Post Office Act 1953:
- (f) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to such length of road;
- (g) the vehicle to be used in the delivery or collection of goods or to be loaded or unloaded except in respect of a road specified in columns 1 to 4 of Schedule 4 to this Order:
- (h) the avoidance of an accident.
- (2) It is not unlawful to cause or permit a disabled person's vehicle to wait on a side or length of road specified in Schedules 1, 2 or 3 to this Order for a period not exceeding 3 hours if-
 - (a) the vehicle displays a valid disabled person's badge and a parking disc in the relevant position;
 - (b) the time at which the period of waiting commenced is marked on the parking disc and
 - (c) a period of at least 1 hour separated the commencement of the period of waiting from any previous period of waiting on that length of road on the same day.

PART 3 - PROHIBITION/RESTRICTION OF LOADING/UNLOADING

- 10. It is unlawful to cause or permit any vehicle to be used for the delivery or collection of goods or to be loaded or unloaded on the sides and lengths of road specified in columns 1 to 4 of Schedule 4 to this Order during the period of operation specified in column 5 of Schedule 4 to this Order.
- 11. It is unlawful to cause or permit a disabled persons vehicle to wait on the sides and lengths of road specified in columns 1 to 4 of Schedule 4 to this Order during the period of operation specified in column 5 of Schedule 4 to this Order.

PART 4 - HACKNEY CARRIAGE STANDS

- 12. It is unlawful to cause or permit any vehicle other than a hackney carriage to wait on the sides and lengths of road specified in columns 1 to 4 of Schedule 5 during the period of operation specified in column 5 of Schedule 5 to this Order.
- 13. It is unlawful to cause or permit a hackney carriage to wait on the sides and lengths of road specified in columns 1 to 4 of Schedule 5 during the period of operation specified in column 5 of Schedule 5 other than for the purpose of plying for hire.
- 14. It is unlawful to cause or permit a hackney carriage to wait on the sides and lengths of road specified in columns 1 to 4 of Schedule 5 outside the period of operation specified in column 5 of Schedule 5 to this Order.

PART 5 - ON STREET PARKING PLACES

15. <u>Designation of Parking Places</u>

The sides and lengths of road specified in columns 1 to 4 of Schedule 6 to this Order are hereby designated as parking places.

16. <u>Vehicles for which Parking Places are Designated</u>

Each parking place may be used, subject to the provisions of this Part of this Order, for the leaving during the charging hours specified in column 5 of Schedule 6 to this Order of such vehicles as are passenger vehicles, goods vehicles, motor cycles or invalid carriages.

17. Marking of the Carriageway of Parking Places and Parking Bays

The limits of each parking place shall be indicated on the carriageway in accordance with diagram 1032 or diagram 1033 in Schedule 6 of the Traffic Signs Regulation and General Directions 2002.

18. <u>Amount of Initial charge at Parking Places</u>

The initial charge for a vehicle in a parking place during the charging hours shall, subject as hereinafter provided, be as set out in column 6 of the 6th Schedule to this Order against the side and length of road specified in that Schedule;

19. Payment of the Initial Charge in Parking Places Where Ticket Machines are Installed

- (1) The Initial Charge payable in a Parking Place where a ticket machine is installed shall be payable on the leaving of a vehicle by the insertion into the ticket machine of coins of the denomination marked on the ticket machine and/or on a tariff board adjacent to the ticket machine to the value of the relevant initial charge.
- (2) Any parking ticket shall be displayed in the relevant position on the vehicle for which it was issued and said ticket shall be so displayed on the vehicle so that the time shown on the front of the said ticket is clearly visible from the front of the vehicle.
- (3) Payment of the initial charge specified in Article 18 shall be indicated by the issue by a ticket machine relating to that parking place of a parking ticket indicating the payment of that initial charge has been paid and by the display of that parking ticket on the vehicle in accordance with the provisions of Article 19(2).
- (4) The day and time shown on any parking ticket issued in the parking places as being the day and time in respect of which the relevant initial charge has been paid shall be presumed unless the contrary is proved to be the day and time in respect of which such initial charge was paid.
- (5) If at any time while a vehicle is left in a parking place no parking ticket indicating that the relevant initial charge has been paid in respect of the day on which the vehicle is so left, is displayed on that vehicle in accordance with the provisions of

Article 19 (2) it shall be presumed unless the contrary is proved that the relevant initial charge has not been paid.

20. <u>Ticket Machines to be Installed at Parking Places</u>

There shall be a ticket machine in the vicinity of each parking place.

21. Vehicles to Leave Parking Place after Expiry of Initial Charge

No person shall display on a vehicle left in a parking place a parking ticket for an Initial Period other than one commencing when the vehicle was first left in that parking place unless the vehicle has first been taken away from that parking place in accordance with Article 22 below.

22. <u>Interval Before Vehicle Again to be Left</u>

No vehicle which has been taken away from a parking place, after the Initial Charge has been incurred, shall until the expiration of one hour from the time it was taken away again be left in that parking place during the charging hours.

23. Manner of Standing in Parking Places

Every vehicle left in a parking place in respect of which the Initial Charge has been incurred shall so stand:

- (a) if the parking place is not in a one-way street, that the left or near side of the vehicle is adjacent and parallel to the left-hand edge of the carriageway;
- (b) if the parking place is in a one-way street, that the left or near side of the vehicle is adjacent and parallel to the left-hand edge of the carriageway or that the right or off-side of the vehicle is adjacent and parallel to the right-hand edge of the carriageway; and
- (c) that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than 0.30 metre.

and in any case so that the vehicle is wholly within any parking place.

24. Alteration of Position of Vehicle in Parking Place

Where any vehicle is standing in a parking place in contravention of the provisions of the immediately preceding Article a parking attendant may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

25. Movement of Vehicles in Parking Places in Emergencies

Any person duly authorised by the Council, or a police constable in uniform may move or cause to be moved, in the case of emergency, to any place he thinks fit, vehicles left in a parking place.

26. Power to Suspend use of Parking Place

- (1) Any person duly authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary always provided that adequate prior notice has been received;
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition or excavation adjacent to or in the parking place;
 - (c) for the purpose of maintenance, improvement or reconstruction of the parking place or any part thereof, of the laying, erection, alteration or repair in or near the parking place of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Section 4(3) of the Telecommunications Act, 1984 or of any traffic sign or parking meter; or
 - (d) for the convenience of occupiers of premises adjacent to the parking place on any occasion of the removal of furniture from one office or dwelling-house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (e) on any such occasion on which it is likely by reason of some special attraction that any street will be throughd or obstructed; or
 - (f) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals or on other special occasions;
- (2) A police constable in uniform may suspend for not longer than 24 hours the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- (3) At the discretion of the Chief Officer of Police a parking place or any part thereof shall be suspended whenever he considers such suspension reasonably necessary to enable the police to discharge their duties.

- (4) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (1), (2) or (3) of this Article may thereupon:-
 - (i) place or cause to be placed on the ticket machine relating to the parking place a cover or notice indicating that the use of the parking place is suspended and that waiting by vehicles is prohibited.
 - (ii) or place or cause to be placed upon the relevant part of the parking place traffic cones (as described in Diagram 7101.1 of Schedule 12 to the Traffic Signs Regulations and General Directions 2002) or such other traffic signs or lights as are appropriate.
- (5) Any person duly authorised by the Council may temporarily remove any ticket machine within that parking place or, as the case may be, any part thereof and any post, bracket or other support on which such ticket machine is fitted and shall thereupon place or cause to be placed in or adjacent to that metered parking place a traffic sign giving the indication referred to in Article 26(4).
- (6) Subject to the provision of Article 26(4) if the use of a parking place is suspended or any part thereof during the charging hours for any of the purposes in Article 26(1) except sub-paragraph (a) a charge of £5.00 shall be payable per day in respect of each 5 metres of the parking place affected (or part thereof if the length is not divisible by 5).
- (7) Subject to the proviso contained herein no person shall cause or permit a vehicle to be left in any part of a parking place during such period as there is a cover noice or traffic sign within the parking place placed in pursuance of Article 26(4) or (5).

Provided that nothing in this paragraph shall apply to:-

- (i) any liveried vehicle being used for fire brigade, ambulance, police or local authority purposes or for any purpose specified in Article 26(1)(a)
- (ii) any other vehicle if that vehicle is so left with the permission of the person who authorised suspension of use of the parking place or part thereof in accordance with the foregoing provisions of this Article, or a police constable in uniform or a parking attendant or other person duly authorised by the Council.

27. Restriction of Use of Vehicles at Parking Places

Unless prior written consent has been granted by the Council, no person shall

- (a) use a vehicle while it is in the parking place in connection with the sale or advertisement of anything to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services or the skill or services of any other person; nor
- (b) use any part of the parking place or any buildings structure mechanical device or other physical feature therein or any vehicle left therein to display advertising

material nor to place upon or attach to any vehicle in the parking place any advertising material to induce the public to participate in or frequent any place function or gathering for the purpose of demonstration or entertainment or to buy or hire or otherwise obtain anything or skill or services of any person and nothing shall be displayed to induce the public to engage for gain in any lottery, sweepstake, raffle or competition.

28. Restriction of Waiting of Vehicles in Parking Places

- (1) Without prejudice to the foregoing provisions of this Order with respect to vehicles which are left in a parking place in accordance with those provisions, any other vehicle may wait during the permitted hours:-
 - (a) anywhere in the parking place if:-
 - (i) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - (ii) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accident;
 - (iii) the vehicle is a vehicle used for fire brigade purposes or an ambulance, or a vehicle (other than a passenger vehicle) in the service of a local authority or a vehicle in the service of a police force in either case being used in pursuance of statutory powers or duties provided always that the vehicle being used for fire brigade, ambulance, police or local authority purposes is a liveried vehicle;
 - (iv) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic:
 - (v) the vehicle is in the service of or employed by the Post Office and is waiting whilst postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle, or, having been unloaded therefrom, are being delivered or while postal packets are being collected from the premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or is in use in connection with the servicing of telephone kiosks adjacent to the parking place;
 - (vi) the vehicle, not being a passenger vehicle, is waiting only for so long as may be reasonably necessary to enable it to be used for any purpose specified in Article 26(1)(b) or (c);
 - (vii) the vehicle, not being a passenger vehicle, is in actual use in connection with the removal of furniture from such premises to a depository or to such premises from a depository; or

- (viii) in any other case the vehicle is waiting for the purpose of delivering or collected goods or merchandise or loading or unloading the vehicle at premises adjacent to the parking place in which the vehicle is waiting and the vehicle does not wait for more than twenty minutes or such longer period as a police constable in uniform, traffic warden in uniform or duly authorised officer of the Council may authorise; and
- (ix) if goods are sold from the vehicle by any person who is licensed by the Council to sell goods from a stationary pitch situated in the parking place.
- (2) No Initial Charge specified in the foregoing provisions of this Order shall be payable in respect of any vehicle waiting in a parking place in accordance with the foregoing provisions of this Article.
- (3) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made under or having effect under Section 25 of the Act or "The Road Vehicles Lighting Regulations 1989".

29. <u>Manner of Waiting in Parking Places</u>

A person causing or permitting a vehicle to wait in a parking place by virtue of Article 28(1)(a)(v, vi and viii) shall take all necessary steps to ensure that the vehicle stands as if left in accordance with Article 23.

30. Exemption from Charges

- (1) If there is displayed within any parking place a Notice placed by a parking attendant to indicate that the ticket machine relating to that parking place is out of order, that notice shall state the maximum length of time (defined in Article 30(2)) during charging hours for which a vehicle may be left in the parking place without payment of any initial charge and if the vehicle is left for longer than that time then a penalty charge shall become payable and the provisions of Articles 85 and 86 shall apply.
- (2) The "maximum length of time" for the purposes of Article 30(1) shall be the maximum stay for the parking place stated in column 6 of the 6th Schedule.
- (3) If a ticket machine which was out of order is repaired during the charging hours then any vehicle left before the repair shall be exempt from charge so long as it is not left for longer than the maximum length of time defined in Article 30(2).
- (4) If a ticket machine is out of order then a parking attendant may instead of placing a notice in accordance with Article 30(1) place a notice nominating another ticket machine or machines in the locality at which a parking ticket may be obtained and that parking ticket shall be valid for the purposes of Article 19
- (5) No charge shall be payable in respect of any vehicle left in a parking place during the charging hours if that vehicle is a disabled persons vehicle or there is validly displayed in the relevant position on the vehicle a disabled person's badge.

- (6) No charge shall be payable in respect of any vehicle left in a parking place during the charging hours if that vehicle displays in the manner specified in Article 19(2) of this Order a duly authorised parking permit issued by the Council which allows the permit holder to park a vehicle in the parking place referred to therein and that vehicle shall be exempt from any limitation on time; or other permit duly authorised by the Council.
- (7) Without prejudice to the generality of the foregoing provisions of this Article nothing in this Article shall be taken to exempt the vehicle or the driver of any vehicle left in any parking place from any other provisions of this Order.

PART 6 - PRIVILEGED PARKING

- . <u>Authorisation of Privileged Parking Places and Power to Suspend use of Privileged</u>
 Parking Places
- 31. Each of the sides and lengths of road specified in columns 1 to 4 of the 7th Schedule to this Order is authorised to be used, subject to the following provisions of this Order, as a privileged parking place for the parking during the permitted hours specified in column 5 of the 7th Schedule for vehicles which display in the manner specified in Article 47 of this Order a valid permit issued by the Council in respect of that vehicle.
- 32. Nothing in Article 31 of this Article shall restrict the power of the Council to close any privileged parking place.

33. <u>Use of Parking Places</u>

A driver of a vehicle shall not use a privileged parking place -

- (a) so as unreasonably to prevent access to any premises adjoining the road or the use of the road by other persons, or so as to be a nuisance, and
- (b) when the Council has closed that privileged parking place.
- 34. The driver of a motor vehicle using a privileged parking place shall stop the engine as soon as the vehicle is in position in the privileged parking place, and shall not start the engine except when about to change the position of the vehicle in or to depart from the privileged parking place.
- 35. No person shall use a vehicle, while it is in a privileged parking place in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services.
- 36. Every vehicle left in a privileged parking place in accordance with the foregoing provisions of this part of this Order shall so stand that every part of the vehicle is contained within the limits of the duly marked privileged parking place.

Alteration of Position of Vehicles from Privileged Parking Places

When a vehicle is waiting in a privileged parking place in contravention of the provision of Article 36 of this Order, a person authorised by the Council to do so may alter or cause to

be altered the position of the vehicle so that its position shall comply with that provision. Any person altering the position of a vehicle by virtue of Article 36 of this Order may do so in such manner as he thinks necessary.

Application for and Issue of Privileged Parking Permits

- 38. Any resident of a dwelling-house or occupier of business premises adjoining any privileged parking place specified in the 7th Schedule who is the owner of a passenger vehicle, a dual purpose vehicle, a light goods vehicle, an invalid carriage or a motor cycle, may apply to the Council for the issue of a privileged parking permit for the parking of that vehicle in a privileged parking place specified in the 7th Schedule and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information as required by such form.
- 39. The Council may require an applicant for a privileged parking permit to produce to an officer of the Council such evidence in respect of the application as he may reasonably require to verify any particulars or information given to him and without prejudice to the generality of the foregoing the Council may require an applicant to produce to an officer of the Council evidence that the applicant has insured the vehicle for at least the minimum risks required to use the vehicle on a highway.
- 40. The Council, upon being satisfied that an applicant is a resident of a dwelling-house or occupier of business premises adjoining any privileged parking place and is the owner of a vehicle of a class specified in Article 38 may issue to that applicant one privileged parking permit for the parking during the permitted hours in a particular privileged parking place or places or zone of privileged parking places specified in the 7th Schedule of the vehicle to which such privileged parking permit relates by the owner or by any person using such vehicle with the consent of the owner (other than a person to whom such vehicle has been let for hire or reward): Provided that, subject to the provisions of Article 41(a) of this Order, the Council shall not issue a privileged parking permit to any person which would be valid for any period to which any other privileged parking permit issued to that person extends;
- 41. (a) Any resident of a dwelling-house or occupier of business premises adjoining any privileged parking place may apply to the Council for the issue of a visitor's privileged parking permit for the leaving of a vehicle which is a passenger vehicle, light goods vehicle or a motor cycle belonging to a person visiting that resident and subject to the other provisions of this Article the Council shall issue a visitor's privileged parking permit to such resident or occupier.
 - (b) In any respect not specifically mentioned in paragraph (a) of this Article the procedure, validity and terms of use for a visitor's privileged parking permit shall be the same as the procedure, validity and terms of use of a resident's privileged parking permit and this part of this Order shall be construed accordingly.
- 42. (a) Any Minister of Religion in whose parish is located any road or parts of a road specified in columns 1 to 4 of the 7th Schedule to this order and any General Practitioner or Health Visitor visiting patients resident in the roads specified in column 1 of the 7th Schedule to this Order may apply to the Council for the issue of a privileged parking permit.
 - (b) The council may require an applicant for a privileged parking permit as referred to in the preceding paragraph or a holder of such a permit to produce to an Officer of the Council

- such evidence in respect of the application as he may reasonably require to verify any particulars or information given to him.
- 43. Notwithstanding any of the other provisions contained in this Article, the Council may also issue a privileged parking permit to any other person, provided that the Council is satisfied that the person is visiting a resident, or business premises and there are exceptional circumstances requiring that person to leave a vehicle under his control in a designated privileged parking place for the duration of the visit.

Surrender, Withdrawal and Validity of Privileged Parking Permits

- 44. (1) A privileged parking permit holder may surrender a privileged parking permit to the Council at any time and shall surrender a privileged parking permit to the Council on the occurrence of any of the events set out in paragraph (3) of this Article.
 - (2) The Council may, by notice in writing served on the privileged parking permit holder at the address shown by that person on the application for the privileged parking permit if it appears to the Council that any of the events set out in paragraph (3) of this Article has occurred and the privileged parking permit holder shall surrender the privileged parking permit to the Council within 72 hours of the receipt of the said Notice.
 - (3) The events referred to in the foregoing provisions of this Article are:-
 - (a) the privileged parking permit holder ceasing to be a resident of a dwelling-house or occupier of business premises adjoining any privileged parking place; specified in the 7th Schedule;
 - (b) the privileged parking permit holder ceasing to be the owner of the vehicle in respect of which the privileged parking permit was issued;
 - (c) the vehicle in respect of which such privileged parking permit was issued being adapted or used in such a manner that it is not a vehicle of a class specified in Article 38 of this Order:
 - (d) the issue of a duplicate privileged parking permit by the Council under the provisions of Article 45 of this Order; or
 - (e) the privileged parking permit was issued on the basis of false information;
 - (f) the privileged parking permit holder has used or permitted the use of the privileged parking permit in circumstances where it was not a valid privileged parking permit'
 - (g) the expiry of the period for which the privileged parking permit was issued.
 - (4) A privileged parking permit shall cease to be valid on the occurrence of any one of the events set out in paragraph (3) of this Article.
 - (5) If the Council withdraws a privileged parking permit it shall be under no obligation to issue a further privileged parking permit to that privileged parking permit holder.

Application for and Issue of Duplicate Privileged Parking Permits

- 45. (1) If a privileged parking permit is mutilated or defaced or the figures or particulars on it have become illegible or the colour of the privileged parking permit has become altered by fading or otherwise, the privileged parking permit holder shall surrender it to the Council and may then apply to the Council for the issue to him of a duplicate privileged parking permit.
 - (2) If a privileged parking permit is lost or destroyed, the privileged parking permit holder may apply to the Council for the issue to him of a duplicate privileged parking permit.
 - (3) The provisions of this part of this Order shall apply to a duplicate privileged parking permit and an application for such a privileged parking permit as if it were a privileged parking permit or, as the case may be, an application for a privileged parking permit.
 - (4) Any privileged parking permit issued by virtue of the provisions of paragraph (1) or (2) of this Article shall be marked as a duplicate, and, upon the issue of a duplicate privileged parking permit, the privileged parking permit which it duplicates shall become void.

Form of Privileged Parking Permits

- 46. A privileged parking permit shall be in writing and shall include the following particulars:-
 - (a) the registration mark of the vehicle in respect of which the privileged parking permit has been issued;
 - (b) the period during which, subject to the provisions of Article 52(4) of the Order, the privileged parking permit shall remain valid; and
 - (c) an authentication that the privileged parking permit has been issued by the Council.
 - (d) the privileged parking place or places or zone of privileged parking places for which the permit is valid

Display of Privileged Parking Permits

47. At all times during which a vehicle is left in a privileged parking place during the permitted hours there shall be displayed on the front of the vehicle a valid privileged parking permit issued in respect of that vehicle so that all the particulars referred to in Article 46 of this Order are readily visible from outside the vehicle.

Restriction on Removal of Privileged Parking Permits

- 48. When a privileged parking permit has been displayed on a vehicle in accordance with the provisions of Article 47 of this Order, no person shall remove the privileged parking permit from the vehicle unless authorised to do so by the driver of the vehicle.
- 49. Save as provided in Article 50 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait during the permitted hours specified in column 5 of the 7th Schedule in any authorised privileged parking space on the lengths of road specified in

columns 1 to 4 of the 7th Schedule to this Order unless the vehicle displays a valid parking privileged parking permit.

- 50. Nothing in Article 49 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of roads referred to in that Article for so long as may be necessary.
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable goods to be loaded onto or unloaded from the vehicle;
 - (c) to enable the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement, or reconstruction of the lengths of roads so referred to or the laying, erection, alteration or repair in or near the said lengths of roads, of any sewer or any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic lines as defined in the Telegraph Act, 1878;
 - (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of Statutory Powers or duties; or
 - (e) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said roads, the said sides of roads or the said lengths of roads.

Charge for Privileged Parking Permits

51. The Council may make such charge as it thinks fit for the issue of any privileged parking permit referred to in this Order.

PART 7 - DOCTORS PARKING PLACES

- 52. The sides and lengths of road specified as doctors parking places in columns 1 to 4 in Schedule 8 to this Order are hereby designated as doctors parking places.
- The number of doctors parking spaces in the doctors parking place referred to in Column 1 to 4 of Schedule 8 shall be the number as specified in column 5 of Schedule 8.
- 54. The doctors parking places referred to in the columns 1 to 4 of Schedule 8 may be used, subject to the provisions of this part, by such vehicles as display in the manner specified in Article 55 of this Order a valid doctors parking permit issued in respect of that vehicle and relating to that doctors parking place.
- 55. At all times during which a vehicle is left in the doctors parking place referred to in Schedule 8 the driver thereof shall cause to be displayed on the front or nearside of the vehicle a valid doctors parking permit issued in respect of that vehicle and relating to that doctors parking place so that all the particulars referred to in Article 69 of this Order are readily visible on the front or nearside of the vehicle.
- Where any vehicle is standing in the doctors parking place in contravention of the provisions of Article 60 of this Order, a constable in uniform or a traffic attendant may alter or cause to be altered the position of the vehicle in order that its position may comply with those provisions.
- 57. Where a parking attendant is of the opinion that the provisions contained in Article 60 of this Order have been contravened he may remove or cause to be removed the vehicle from the doctors parking place and, where it is so removed, shall provide for the safe custody of the vehicle.
- 58. A constable in uniform or a parking attendant parking attendant may move or cause to be moved, in case of emergency, to any place he thinks fit any vehicle left in the doctors parking place.
- 59. Where a doctors parking permit has been displayed on a vehicle in accordance with the provisions of this part of this Order no person, not being a driver of the vehicle, shall remove the doctors parking permit from the vehicle unless authorised to do so by the driver of the vehicle.
- 60. Manner of Standing in Doctors Parking Places

Every vehicle left in a doctors parking place shall so stand:

- (a) if the doctors parking place is not in a one-way street, that the left or near side of the vehicle is adjacent and parallel to the left-hand edge of the carriageway;
- (b) if the doctors parking place is in a one-way street, that the left or near side of the vehicle is adjacent and parallel to the left-hand edge of the carriageway or that the right or off-side of the vehicle is adjacent and parallel to the right-hand edge of the carriageway; and
- (c) that the distance between the edge of the carriageway and the nearest wheel of the vehicle is not more than 0.30 metre.

and in any case so that the vehicle is wholly within any doctors parking place.

61. Alteration of Position of Vehicle in Doctors Parking Place

Where any vehicle is standing in a doctors parking place in contravention of the provisions of the immediately preceding Article a parking attendant may alter or cause to be altered the position of the vehicle in order that its position shall comply with those provisions.

62. <u>Movement of Vehicles in Doctors Parking Places in Emergencies</u>

Any person duly authorised by the Council, or a police constable in uniform may move or cause to be moved, in the case of emergency, to any place he thinks fit, vehicles left in a doctors parking place.

- 63. (1) Any person duly authorised by the Council may suspend the use of the doctors parking place or any part thereof whenever he considers such suspension is reasonably necessary;
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition or excavation adjacent to the parking place, the maintenance, improvement or reconstruction of the highway, the laying, erection, alteration or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telegraph Act 1878 or removal of any traffic sign;
 - (c) for the convenience of occupiers or premises adjacent to the doctors parking place on any occasion of the removal of furniture to or from one office or dwellinghouse adjacent to the parking place from or to a depository, another office or dwellinghouse;
 - (d) for the convenience of occupiers of premises adjacent to the doctors parking place at times of weddings or funerals, or on other special occasions.
 - (2) A police constable in uniform may suspend for not longer than 24 hours the use of the doctors parking place or any part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
 - (3) Any person or constable in uniform suspending the use of a doctors parking place or any part thereof in accordance with the provisions of paragraph (1) or as the case may be paragraph (2) of this article shall thereupon place or cause to be placed in or adjacent to the doctors parking place or as the case may be that part thereof and the use of which is suspended a traffic sign as prescribed or authorised under Section 64 of the Act of 1984 indicating that waiting by vehicles is prohibited.
 - (4) Save as provided in Article 64 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait during the permitted hours specified in

column 6 of Schedule 8 to this Order in any doctors parking place designated as such in Article 60 unless the vehicle displays a valid doctors parking permit. No person shall cause or permit a vehicle to wait in any part of a doctors parking place during such period as there is in or adjacent to that part of the doctors parking place a traffic sign placed in pursuance of paragraph (3) of this Article:

Provided that nothing in this paragraph shall apply -

- (i) in respect of any liveried vehicle being used for the fire brigade, ambulance or police purposes or any vehicle which is waiting for any reason specified in paragraphs (1)(a) or (1)(c) of Article 64 of this Order; or
- (ii) to anything done with the permission of the person suspending the use of the doctors parking place or part thereof in pursuance of paragraph (1) of this Article, a constable in uniform or a traffic warden or parking attendant.
- 64. (1) It is not unlawful to cause or permit a vehicle to wait during the permitted hours in the doctors parking place if the use of the place has not been suspended and if
 - (a) the vehicle is waiting only for so long as is necessary to enable a person to board or alight from the vehicle;
 - (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident;
 - (c) the vehicle is being used for fire brigade purposes or it an ambulance, or a vehicle (other than a passenger vehicle) in the service of a local authority or a vehicle in the service of a police force in any case being used in pursuance of statutory powers or duties provided the vehicle is a liveried vehicle;
 - (d) the vehicle is waiting for only so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic.
 - (2) Except as provided by this Part of this Order the driver or person in charge of the vehicle shall not cause or permit a vehicle to wait in the doctors parking place during the doctors permitted hours.

65. The Council shall:

- (a) cause the limits of the doctors parking place to be indicated on the carriageway by placing and maintaining thereon appropriate traffic signs prescribed or authorised under Section 64 of the Act of 1984; and
- (b) place or maintain in or in the vicinity of the doctors parking place traffic signs prescribed or authorised under Section 64 of the Act of 1984 indicating the number of such parking place and that such parking place may be used during the permitted hours for the leaving only of the vehicle specified in Article 54 the Order; and
- (c) carry out such other work as is reasonably required for the purposes of the satisfactory operation of the doctors parking place.
- 66. (1) Any fully registered person may apply to the Council for the issue of a doctors permit in respect of each vehicle which shall be specified in the application an any such application shall be made on a form issued by and obtainable from the Council and shall include the particular information and authentication required by such form to be supplied.
 - (2) The council may at any time require an applicant for a doctors permit or a doctors permit holder to produce to an officer of the Council such evidence in respect of an application for a doctors permit made to them as they may reasonably call for to verify any particulars or information given to them or in respect of any doctors permit issued by them as they may reasonably call for to verify that the doctors permit is valid.
 - (3) Upon receipt of an application duly made under the foregoing provisions of this Article, the Council may issue to the applicant doctors permits for the leaving in the doctors parking place specified thereon of such vehicles specified in the application as parking they are satisfied are used by fully registered persons who are liable to be called, of necessity to emergencies away from the surgery or consulting rooms shown on such application to the extent that the need for special parking arrangements is justified and to whom no suitable alternative parking facility is available within a reasonable distance.
- 67. (1) A doctors permit holder may surrender a permit to the Council at any time and shall surrender a permit to the Council on the occurrence of any one of the events set out in paragraph (3) of this Article.
 - (2) The Council may, by notice in writing served on the doctors permit holder at the address shown by that person on the application for the doctors permit or any other address believed to be that person's place of abode, withdraw a permit if it appears to the Council that any one of the events set out in paragraph (3)(a) or (3)(c) of this Article has occurred and the doctors permit holder shall surrender the permit to the Council within 48 hours of the receipt of the aforementioned notice.

- (3) The events referred to in the foregoing provisions of this Article are:
 - (a) the vehicle or any vehicle in respect of which the doctors permit was issued ceasing to be used by a fully registered person who is liable to be called, of necessity, to emergencies away from the surgery of consulting rooms shown on the application for that doctors permit to the extent that the need for special parking arrangements can be justified;
 - (b) the withdrawal of such doctors permit by the Council under paragraph (2) of this Article;
 - (c) the revocation of the designation of the doctors parking place in respect of which the permit was issued;
 - (d) the issue of a revised doctors permit or a duplicate doctors permit by the Council under the provisions of Article 68(2) or 68(3) of this Order;
 - (e) the doctors permit ceasing to be valid pursuant to the provisions of paragraph (4) of this Article
- (4) Without prejudice to the foregoing provisions of this Article, a doctors permit shall cease to be valid at the expiration of the period specified thereon (which period shall not exceed a period of 12 months) from the beginning of the month during which it first became valid or on the occurrence of any one of the events set out in paragraph 3(a), 3(b), 3(c) or 3(d) of this Article, whichever is the earlier.
- (5) Nothing in the foregoing provisions of this Article shall affect the validity of or require the surrender of or enable the Council to withdraw the doctors permit or not review it on the grounds that the event set out in paragraph (3)(a) of this Article has occurred if a doctors permit holder has duly applied to t he Council for the permit to be amended pursuant to Article 68(1) of this Order.
- 68. (1) (a) A doctors permit holder may at any time apply to the Council for a doctors permit issued to him to be amended so as to relate to any other vehicle or any additional vehicle or both being in either case a vehicle which is used by a fully registered person who is liable to be called, of necessity, to emergencies away from the surgery or consulting room shown on the application for that permit to the extent that the need for special parking arrangements.
 - (b) Upon receipt of an application pursuant to sub-paragraph (1)(a) and of the relevant permit, the Council may amend the doctors permit accordingly or to such lesser extent as they think fit, at, at their discretion issue a revised permit, and if a revised doctors permit is issued, the doctors permit shall become invalid and shall be surrendered to the Council.

- (2) If a doctors permit is mutilated or accidentally defaced or the figures or particulars thereon become illegible of the colour of the permit has become altered by fading or otherwise, the permit holder either shall surrender it to the Council or apply to the Council for the issue to him of a duplicate doctors permit and the Council upon receipt of the doctors permit shall issue a duplicate doctors permit and upon such issue the doctors permit shall become invalid.
- (3) If a doctors permit is lost or destroyed, the doctors permit holder may apply to the Council for the issue to him of a duplicate doctors permit and the Council, upon being satisfied as to such loss or destruction, shall issue a duplicate doctors permit so marked and upon such issue the doctors permit shall become invalid.
- (4) The provisions of this Part of this Order shall apply to a revised doctors permit or a duplicate doctors permit and an application therefore as if it were a permit or as the case may be an application therefore.
- 69. A doctors permit shall be in writing and shall include the following particulars:
 - (a) the registration mark of the vehicle in respect of which the doctors permit has been issued:
 - (b) the period during which, subject to the provisions of Article 67(4) of this Order, the doctors permit shall remain valid;
 - (c) the number of the doctors parking place to which the doctors permit relates;
 - (d) an indication that the doctors permit has been issued by the Council;
 - (e) the hours during which the vehicle in respect of which the doctors permit has been advised may be left in the doctors parking place.

PART 8 - PROHIBITION OF STOPPING AT SCHOOL ENTRANCES

- 70. Save as provided in Article 71 to this Order no person shall cause or permit any vehicle to stop between the hours of 8.00am and 5.00pm on Monday to Friday on the school entrance markings on the sides and lengths specified in columns 1 to 4 of Schedule 9 to this Order.
- 71. Nothing in Article 70 of this Order shall render it unlawful to cause or permit any vehicle to stop on the school entrance markings specified in that Article so far as such stopping is reasonably necessary for the vehicle to be used for the following purposes:-
 - (a) the removal of any obstruction to traffic
 - (b) police, fire brigade or ambulance purposes provided that the vehicle being used is a liveried vehicle
 - (c) in pursuance of statutory powers or duties
 - (d) the maintenance, improvement or reconstruction of the length of road comprised of the school entrance markings or the laying, erection, alteration or repair in or

adjacent to the said school entrance markings of any sewer, main, pipe, or apparatus for the supply of gas, water, electricity or any telecommunication apparatus as defined in the Telecommunications Act 1984.

PART 9 - DISABLED PERSONS PARKING SPACES

- 72. Save as provided in Article 73, no person shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit a vehicle to wait during the period of operation specified in column 7 of Schedule 10 on the sides and lengths of road specified in columns 1 to 4 of Schedule 10
- 73. It is not unlawful to cause or permit a vehicle to wait on the sides and lengths of road specified in columns 1 to 4 of Schedule 10 for a period not exceeding that specified in column 5 of Schedule 10 provided
 - (a) the vehicle displays a disabled person's badge and a parking disc in the relevant position;
 - (b) the quarter-hour period during which the period of waiting commenced is marked on the parking disc; and
 - (c) the period specified in column 6 separated the commencement of the period of waiting from any previous period of waiting on the same length of road by the same vehicle on the same day
- 74. It is not unlawful to cause or permit a vehicle to wait on the sides and lengths of road specified in columns 1 to 4 in Schedule 10 for so long as may be necessary to enable:-
 - (a) the laying, erection, alteration or repair in, or in land adjacent to, such length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telecommunications Act 1984
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or North West Water Limited in pursuance of statutory powers or duties;
 - (c) the vehicle to be used for fire services, ambulance or police purposes or in connection with a funeral provided that the vehicle being used for fire service, ambulance or police purposes is a liveried vehicle;

PART 10 - STANDS FOR PUBLIC SERVICE VEHICLES

- 75. The sides and lengths of road specified in columns 1 to 4 of Schedule 11 shall be a stand at all times for public service vehicles.
- 76. No person shall except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant cause or permit a vehicle other than a public service vehicle to wait on the sides and lengths of road specified in columns 1 to 4 of Schedule 11.
- 77. Every public service vehicle using the said stand shall wait thereon in single line with its nearside by the kerb and parallel thereto.

PART 11 - DRIVING TEST CANDIDATES PARKING PLACES

- 78. The lengths of road specified in columns 1 to 4 of Schedule 12 to this order are authorised to be used during the period of operation specified in column 5 of Schedule 12 as a parking place for a vehicle in which an appointment letter is displayed in the vehicle immediately behind either the windscreen or the nearside window with side showing the date and time facing outwards.
- 79. The driver of a vehicle shall not permit the vehicles to wait in such parking place unless an appointment letter is displayed in the vehicle in the relevant position.
- 80. No person shall cause or permit a vehicle to wait in such parking place at a time -
 - (a) more than 15 minutes before the time specified on the appointment letter; or
 - (b) more than 45 minutes after that time. Monday to Friday only.

PART 12 - AUTHORISED LOADING BAYS

- 81. Save as provided in Article 82 of this Order no person shall, except the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit any vehicle to enter proceed or wait in the loading bay described in columns 1 to 4 Schedule 14 to this Order otherwise than for the purpose of the loading or unloading or any goods at premises adjacent to or accessible only from the loading bay during the period of operation specified in column 5 of Schedule 14 to this Order.
- 82. (1) Nothing in this part of this Order shall render it unlawful for any person to cause or permit any vehicle to enter or proceed in the loading bay so far as such entry or proceeding is reasonably necessary to enable the vehicle to be used for any of the purposes specified in paragraph (2) of this Article or to wait in a loading bay for so long as may be necessary for any of those purposes.

- (2) It is not unlawful to cause or permit a vehicle to wait on specified side of a specified length of road for so long as may be necessary to enable -
 - (a) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in or in connection with any of the following operations, namely -
 - (i) building, engineering or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of such length of road; or
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, such length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line as defined in the Telecommunications Act 1984
 - (b) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or North West Water Limited in pursuance of statutory powers or duties;
 - (c) the vehicle to be used for fire services, ambulance or police purposes or in connection with a funeral provided that the vehicle used for fire services, ambulance or police purposes is a liveried vehicle;
 - (d) the vehicle to be used in the delivery or collection or postal packets as defined in Section 87 of the Post Office Act 1953:
 - (e) the avoidance of an accident.

PART 13 - BUS STOP CLEARWAYS

- 83. Save as provided in Article 84 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle, other than a bus to wait in a bus stop area on any day during the period of operation specified in column 5 of Schedule 13 to this Order
- 84. Nothing in Article 83 of this Order shall render it unlawful for a person to cause or permit a vehicle to wait in a bus stop area -
 - (a) if the vehicle is being used for the removal of any obstruction to traffic;
 - (b) if the vehicle is being used in the service of a local authority or a water company in exercise of statutory powers or duties and whilst being so used in such service it is necessary for the vehicle to wait in that bus stop area;
 - (c) if the vehicle is being used for police, fire brigade or ambulance purposes provided that the vehicle is liveried; or
 - (d) in any case where the person in control of the vehicle -

- (i) is required by law to stop
- (ii) is obliged to stop so as to prevent an accident
- (iii) is prevented from proceeding by circumstances beyond his control.

PART 14 - GENERAL

85. Penalty Charges

- (1) If a vehicle is left in a parking place during the permitted hours or in any road or length of road in contravention of any provision of this Order, a penalty charge shall be payable and/or the vehicle may be removed from that location.
- (2) In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by section 66(3) of the Road Traffic Act 1991 may then be issued by a parking attendant in uniform in accordance with section 66(1) of the said Act.
- (3) If a vehicle is left after a penalty charge has been incurred, a parking attendant in uniform or a person acting under his direction may attach to the vehicle an immobilisation device and a notice in accordance with the requirements of section 69(1) and (2) of the Road Traffic Act 1991 and that vehicle shall only be released from the device on payment of the penalty charge, or as the case may be a reduced penalty charge, along with such release fee as may be required by the Council.
- (4) Where a parking attendant has removed or caused to be removed a vehicle in accordance with paragraph (1) of this Article:-
 - (a) he shall provide for the safe custody of the vehicle;
 - (b) the Council shall be entitled to recover from the person responsible such charges in respect of the removal, storage and disposal of the vehicle as it might prescribe from time to time;
 - (c) the provisions of the Road Traffic Regulation Act 1984 as amended shall apply to the disposal of any such vehicle removed by or on behalf of the Council pursuant to this Article.

Nothing in paragraphs (3) and (4) of this Article shall apply in respect of a vehicle displaying in the relevant position a valid disabled person's badge issued by any local authority."

86. Manner of Payment of Penalty Charge and Reduced Penalty Charge

- (1) A Penalty Charge can be discharged by the driver of a vehicle in respect of which a Penalty Charge has been incurred paying a Reduced Penalty Charge to the Council in the amount and manner prescribed on the Penalty Charge Notice (or the rear thereof) so as to reach the Council within the period ending at 4.00 p.m. on the 14th day following the day on which the Penalty Charge was incurred.
- (2) If the Penalty Charge is not discharged in accordance with Article 23(1) above then the Penalty Charge shall be discharged by the driver of a vehicle in respect of which a Penalty Charge has been incurred paying the full amount of the Penalty Charge in the amount and manner prescribed on the Penalty Charge Notice (or the rear thereof) so as to reach the Council within the period ending at 4.00 p.m. on the 28th day following the day on which the Penalty Charge was incurred."

In the event that either of the said 14th or 28th day falls upon a day on which the offices of the said Legal and Property Services Department are closed, the period within which payment of the Penalty Charge or Reduced Penalty Charge shall be made, shall be extended until 4.00 p.m. on the next full day on which the said offices are open."

87. <u>Derogation and Precedence over other Orders</u>

- (1) The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- (2) Where the provisions of any Order made or having effect as if made under the Act of 1984 which imposes any prohibition or restriction on waiting by vehicles or grant any exemption from such prohibition or restriction relate to a length of road designated as a parking place in this Order the provisions of the parking place in this Order shall prevail.
