

**WIGAN BOROUGH COUNCIL**

**THE WIGAN BOROUGH (DECriminalISATION OF PARKING)  
(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION  
CONSOLIDATION) AMENDMENT ORDER 2004**

The Wigan Borough Council, in exercise of its powers under Section 1 of The Road Traffic Act 1984 and the Road Traffic Act 1991 and of all other powers enabling it in that behalf hereby makes the following Order –

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Amendment Order 2004 and shall come into operation on 7<sup>th</sup> March 2005.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

- (a) In relation to Schedule One the following entries shall be deleted from Schedule One to the Order.

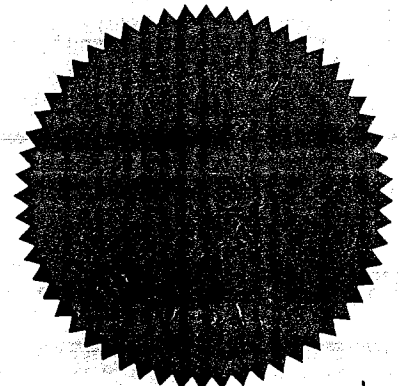
