Council Avenue, Ashton-in- Makerfield	North	Its junction with Bryn Street	A point 10 metres west of its junction with Bryn Street	On any Monday, Tuesday, Wednesday, Thursday or Friday 7.30am -9.30am and 4.00pm-6.30pm

(b) In relation to Schedule Four the following entries shall be added to Schedule Four to the Order:-

Council Avenue, Ashton-in- Makerfield	South	Its junction with Bryn Street	A point 58 metres west of its junction with Bryn Street	On any Monday, Tuesday, Wednesday, Thursday or Friday 7.30am -9.30 am and 3.00pm -6.30pm
Council Avenue, Ashton-in- Makerfield	North	Its junction with Bryn Street	A point 10 metres west of its junction with Bryn	On any Monday, Tuesday, Wednesday, Thursday or Friday 7.30am -9.30 am and

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking)(Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 shall remain in force.
