

THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)
(VARIOUS ROADS IN WIGAN BOROUGH))(TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004 (AMENDMENT NO.15) ORDER 2005

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 (Amendment No.15) Order 2005 and shall come into operation on 16th December 2005.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

- (a) In relation to Schedule Four, the following entries shall be deleted from Schedule Four to the Order:-

Council Avenue, Ashton-in-Makerfield	South	Its junction with Bryn Street	A point 58 metres west of its junction with Bryn Street	On any Monday, Tuesday, Wednesday, Thursday or Friday 7.30am -9.30 am and 3.00pm -6.30pm
