THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING) (LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 2) ORDER 2005

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Act 1984 and the Road Traffic Act 1991 and of all other powers enabling it in that behalf hereby makes the following Order: -

- The Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 2) Order 2005 and shall come into operation on 23rd December 2005
- 2. The Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:
 - a) In relation to Schedule One the following entries shall be added to Schedule One to the Order:-
