

## WIGAN BOROUGH COUNCIL

### THE WIGAN BOROUGH (DECriminalISATION OF PARKING) (VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004 (AMENDMENT NO. 21) ORDER 2006

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 21) Order 2006 and shall come into operation on 20<sup>th</sup> February 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

- (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Cross Street, Hindley	Both	Its junction with Wigan Road	Its junction with Market Street
Morris Street, Hindley	Both	Its junction with Wigan Road	Its junction with Cross Street
Wigan Road, Hindley	Both	Its junction with Darby Lane	Its junction with Atherton Road

- (b) In relation to Schedule Two, the following entries shall be deleted from Schedule Two to the Order:-

Cross Street, Hindley	Both	Its junction with Wigan Road	Its junction with Market Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 8.00pm
Morris Street, Hindley	Both	Its junction with Wigan Road	Its junction with Cross Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 8.00pm
Wigan Road, Hindley	North East	Its junction with Darby Lane	Its junction with Atherton Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 8.00pm

Wigan Road, Hindley	South West	A point 65 metres north west of its junction with Darby Lane	Its junction with Atherton Road	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 8.00pm

- (c) In relation to Schedule Two the following entry shall be added to Schedule Two to the Order:-

Wigan Road, Hindley	South West	A point 65 metres north west of its junction with Darby Lane	Its junction with Darby Lane	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am – 6.00pm

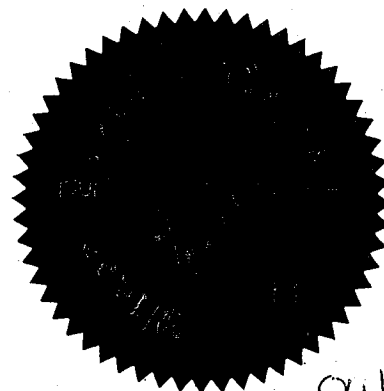
