**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)**  
**(VARIOUS ROADS IN WIGAN BOROUGH)**  
**(TRAFFIC REGULATION CONSOLIDATION) ORDER 2004**  
**(AMENDMENT NO. 20) ORDER 2006**

The Wigan Borough Council in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 hereby makes the following Order:-

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 20) Order 2006 and shall come into operation on 20 February 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:
  - a. In relation to Schedule One the following entry shall be deleted from Schedule One to the Order:-

Bolton Road, Ashton-in-Makerfield	North West	A point 53 metres north east of its junction with Bryn Road South	A point 38 metres south west of its junction with Bryn Road South

- b. In relation to Schedule One the following entry shall be added to Schedule One to the Order

Bolton Road, Ashton-in-Makerfield	North West	Its junction with George Street	A point 38 metres south west of its junction with Bryn Road South

- c. In relation to Schedule Four, the following entry shall be deleted from Schedule Four to the Order:-

Bolton Road, Ashton-in-Makerfield	North West	A point 53 metres north east of its junction with Bryn Road South	A point 38 metres south west of its junction with Bryn Road South	On any Monday, Tuesday, Wednesday, Thursday or Friday 7.30am – 9.30am and 4.00pm – 6.30pm

- d. In relation to Schedule Four the following entry shall be added to Schedule Four to the Order:-

Bolton Road, Ashton-in-Makerfield	North West	A point 63 metres east of its junction with Bryn Road South	A point 38 metres south west of its junction with Bryn Road South	On any Monday, Tuesday, Wednesday, Thursday, or Friday 7.30a.m. – 9.30am and 4.00pm - 6.30p.m.

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 shall remain in force.
