

**WIGAN BOROUGH COUNCIL**

**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)  
(LEIGH ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER  
2004 (AMENDMENT NO 4) ORDER 2006**

The Wigan Borough Council in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and of all other powers enabling it in that behalf hereby makes the following Order:-

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No 4) Order 2006 and shall come into operation on 17<sup>th</sup> April 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
  - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Kirkhall Lane, Leigh	East	A point 10 metres north of its junction with Westbourne Avenue	A point 6 metres south of its junction with Westbourne Avenue
-------------------------	------	---	---

Kirkhall Lane, Leigh	East	Its junction with Holt Street	A point 10 metres north of its junction with Holt Street
-------------------------	------	----------------------------------	---

Kirkhall Lane, Leigh	West	Its junction with Holt Street	Its junction with Unsworth Street
-------------------------	------	----------------------------------	--------------------------------------

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Leigh Roads) (Traffic Regulation Consolidation) Order 2004 shall remain in force.
4. The Wigan Borough (Kirkhall Lane/Westbourne Avenue, Leigh) (Prohibition of Waiting) Order 2004 is hereby revoked only insofar as it relates to the introduction of no waiting at any time on the east side of Kirkhall Lane, Leigh from a point 10 metres north of its junction with Westbourne Avenue to a point 10 metres south of its junction with Westbourne Avenue.
