

**WIGAN BOROUGH COUNCIL**

**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING) (VARIOUS ROADS IN  
WIGAN BOROUGH)  
(TRAFFIC REGULATION CONSOLIDATION) ORDER 2004  
(AMENDMENT NO. 34) ORDER 2006.**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 34) Order 2006 and shall come into operation on 15<sup>th</sup> May 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
  - (a) In relation to Schedule One, the following entry shall be deleted from Schedule One to the Order:-

Bellingham Drive, Wigan	Both	Its junction with Wigan Lane.	A point 38 metres east of its junction with Wigan Lane.

- (b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Bellingham Drive, Wigan	North	Its junction with Wigan Lane.	For a distance of 3 metres in an easterly direction.
Bellingham Drive, Wigan	North	From a point 30 metres east of Wigan Lane	For a distance of 8 metres in an easterly direction.
Bellingham Drive, Wigan	South	From its junction with Wigan Lane.	For a distance of 38 metres in an easterly direction.

- (c) In relation to Schedule Seven, the following entry shall be added to Schedule Seven to the Order:-

Bellingham Drive, Wigan	North	From a point 3 metres east of Wigan Lane.	For a distance of 27 metres	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00a.m to 5.00p.m.

3. Save as provided in relation to the above amendments. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 shall remain in force.
