**THE WIGAN BOROUGH (DECriminalISATION OF PARKING)
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.14) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.14) Order 2006 and shall come into operation on 14th April 2006
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
 - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Market Place, Wigan	East	Its junction with Library Street	For a distance of 46 metres in a northerly direction

(c) In relation to Schedule Fourteen, the following entries shall be added to Schedule Fourteen to the Order:-

Market Place, Wigan	East	A point 46 metres north of its junction with Library Street	For a distance of 26 metres in a northerly direction	Midnight – 10.30 am and 4.00 pm to midnight on any day

Market Place, Wigan	West	A point 78 metres north of its junction with Library Street	For a distance of 32 metres in a northerly direction	Midnight – 10.30 am and 4.00 pm to midnight on any day

3. Save as provided in relation to the above amendments The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 shall remain in force.
