**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO. 3) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 and of all others enabling it in that behalf hereby makes the following Order:-

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.3) Order 2006 and shall come into operation on 13th February 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
 - a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Market Street, Wigan	North	Its junction with Hallgate	Its junction with Market Place ✓
Market Street, Wigan	South	Its junction with Hallgate	A point 16 metres south east of its junction with Hallgate ✓
Market Street, Wigan	South	A point 37.6 metres south east of its junction with Hallgate	Its junction with Market Place ✓
Standishgate, Wigan	West	A point 110 metres north of its junction with Library Street	For a distance of 14 metres in a northerly direction ✓
Standishgate, Wigan	West	A point 168 metres north of its junction with Library Street	For a distance of 30.5 metres in a northerly direction ✓
Standishgate, Wigan	West	A point 231.5 metres north of its junction with Library Street	Its junction with Crompton Street ✓

- b) In relation to Schedule Four, the following entries shall be added to Schedule Four to the Order:-

Market Street, Wigan	North	Its junction with Hallgate	Its junction with Market Place	At any time ✓
Market Street, Wigan	South	Its junction with Hallgate	A point 16 metres south east of its junction with Hallgate	At any time ✓

Market Street, Wigan	South	A point 37.6 metres south east of its junction with Hallgate	Its junction with Market Place	At any time

Standishgate, Wigan	West	A point 110 metres north of its junction with Library Street	For a distance of 14 metres in a northerly direction	At any time

- c) In relation to Schedule Fourteen, the following entries shall be added to Schedule Fourteen to the Order:-

Market Street, Wigan	South	A point 16 metres south east of its junction with Hallgate	For a distance of 21.6 metres in a south easterly direction	Midnight – 10.30am and 4.00pm – midnight on any day

Standishgate, Wigan	West	A point 124 metres north of its junction with Library Street	For a distance of 44 metres in a northerly direction	Midnight – 10.30am and 4.00pm – midnight on any day

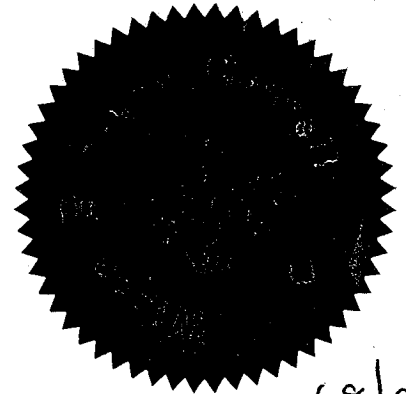
Standishgate, Wigan	West	A point 198.5 metres north of its junction with Library Street	For a distance of 33 metres in a northerly direction	Midnight – 10.30am and 4.00pm – midnight on any day
