**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)  
(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION) ORDER  
2004 (AMENDMENT NO 49) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.49) Order 2006 and shall come into operation on 23<sup>rd</sup> October 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
  - (a) In relation to Schedule Two, the following entry shall be deleted from Schedule Two to the Order:-

Manchester Road, Astley	South	Its junction with Coldalhurst Lane	A point 21 metres east of its junction with Princes Avenue	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.30am – 6.30pm

- (b) In relation to Schedule Two the following entry shall be added to Schedule Two to the Order:-

Manchester Road, Astley	South	A point 15 metres west of its junction with Lodge Drive	A point 21 metres east of its junction with Prince's Avenue	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 7.30am – 6.30pm

- (c) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Manchester Road, Astley	South	A point 15 metres west of its junction with Lodge Drive	A point 15 metres east of its junction with Coldalhurst Lane
Coldalhurst Lane, Astley	East	Its junction with Manchester Road	A point 14 metres south of its junction with Manchester Road

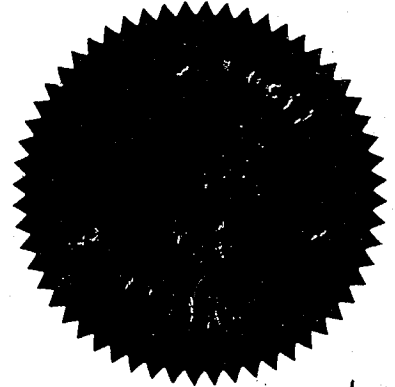
Coldalhurst Lane, Astley	West	Its junction with Manchester Road	A point 10 metres south of its junction with Manchester Road
Lodge Drive, Astley	West	Its junction with Manchester Road	For a distance of 20 metres in a southerly then westerly direction
Lodge Drive, Astley	East	Its junction with Manchester Road	For a distance of 20 metres in a southerly then easterly direction

3. Save as provided in relation to the above amendments. The Wigan Borough (Decriminalisation of Parking)(Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 shall remain in force.
