**THE WIGAN BOROUGH(DECriminalISATION OF PARKING)**  
**(WIGAN ROADS NO. 2) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004**  
**(AMENDMENT NO. 11) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 11) Order 2006 and shall come into operation on 23<sup>rd</sup> October 2006.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads No. 2)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
  - (a) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Tan House Drive, Winstanley	West	a point 10 metres north east of its junction with Chiltern Drive	a point 10 metres south west of its junction with Chiltern Drive	✓

Amesbury Drive, Winstanley	Both	its junction with Tan House Drive	for a distance of 10 metres in a south westerly direction	✓

- (b) In relation to Schedule Nine, the following entry shall be added to Schedule Nine to the Order:-

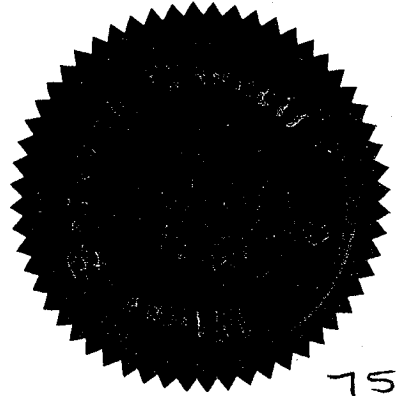
Tan House Drive, Winstanley	West	A point 69 metres north west of its junction with Chiltern Drive	For a distance of 43.56 metres in a south westerly direction	✓
