**THE WIGAN BOROUGH (DECriminalISATION OF PARKING)
(WIGAN ROADS) (TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO.24) ORDER 2006**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Wigan Roads) (Traffic Regulation Consolidation) Order 2004 (Amendment No.24) Order 2006 and shall come into operation on 8th January 2007.
2. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

- (a) In relation to Schedule One, the following entry shall be deleted from Schedule One to the Order:-

Wigan Lane, Wigan	West	Its junction with Kingsmede	A point 83 metres north of its junction with Clifton Crescent

- (b) In relation to Schedule One, the following entry shall be added to Schedule One to the Order:-

Wigan Lane, Wigan	West	Its junction with Kingsmede	A point 73 metres north of its junction with Clifton Crescent

- (c) In relation to Schedule Four, the following entry shall be deleted from Schedule Four to the Order:-

Wigan Lane, Wigan	West	Its junction with Kingsmede	A point 83 metres north of its junction with Clifton Crescent	At any time

- (d) In relation to Schedule Four, the following entry shall be added to Schedule Four to the Order:-

Wigan Lane, Wigan	West	Its junction with Kingsmede	A point 73 metres north of its junction with Clifton Crescent	At any time

- (e) In relation to Schedule Six, the following entry shall be deleted from Schedule Six to the Order:-

Wigan Lane, Wigan	West	A point 83 metres north of its junction with Clifton Crescent	Its junction with Kingsmede	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am – 5.00pm	During the charging hours an initial charge of (a) 50 pence per half hour or (b) 70 pence per hour Or any part thereof subject to a maximum stay of one hour after which time the excess charge shall apply

- (f) In relation to Schedule Six, the following entry shall be added to Schedule Six to the Order:-


Wigan Lane, Wigan	West	A point 73 metres north of its junction with Clifton Crescent	Its junction with Kingsmede	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 9.00am – 5.00pm	During the charging hours an initial charge of (a) 60 pence per half hour or (b) 80 pence per hour Or any part thereof subject to a maximum stay of one hour after which time the excess charge shall apply
-------------------	------	---	-----------------------------	---	--

3. Save as provided in relation to the above amendments. The Wigan Borough (Decriminalisation of Parking) (Wigan Roads)(Traffic Regulation Consolidation) Order 2004 shall remain in force.
