**THE WIGAN BOROUGH (DECRIMINALISATION OF PARKING)**  
**(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)**  
**ORDER 2004 (AMENDMENT NO. 47) ORDER 2007**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 47) Order 2007 and shall come into operation on 12<sup>TH</sup> March 2007.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

- (a) In relation to Schedule One, the following entry shall be deleted from Schedule One to the Order:-

Atherton Road, Hindley Green	South west	A point 77 metres north west of its junction with Lincroft Road	Its junction with Greenbank

- (b) In relation to Schedule One, the following entry shall be added to Schedule One to the Order:-

- (c) In relation to Schedule Two, the following entry shall be deleted from Schedule Two to the Order:-

Atherton Road, Hindley Green	Both	Its junction with Greenbank	A point 15 metres north west of its junction with Organ Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00 am - 6.30pm.

- (d) In relation to Schedule Two, the following entries shall be added to Schedule Two to the Order:-

Atherton Road, Hindley Green	North	Its junction with Kirkpatrick Street	A point 15 metres north west of its junction with Organ Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00 am - 6.30pm.

Atherton Road, Hindley Green	South West	A point 25 metres south east of its junction with Greenbank	A point 15 metres north west of its junction with Organ Street	On any Monday, Tuesday, Wednesday, Thursday, Friday or Saturday 8.00am - 6.30pm

- (e) In relation to Schedule Four, the following entries shall be added to Schedule Four to the Order.

Atherton Road, Hindley Green	South west	A point 25 metres north west of its junction with Lincroft Road	A point 25 metres south east of its junction with Greenbank	At any time

Lincroft Road, Hindley Green	Both	Its junction with Atherton Road	A distance of 17 metres in a south westerly direction	At any time

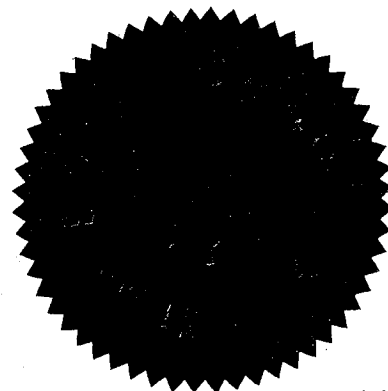
