THE WIGAN BOROUGH (DECriminalISATION OF PARKING)
(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)
ORDER 2004 (AMENDMENT NO.54) ORDER 2007

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991, hereby makes the following Order -

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No.54) Order 2007 and shall come into operation on 28th July 2007.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-

- (a) In relation to Schedule One, the following entry shall be added to Schedule One to the Order:-

Manchester Road, Leigh	South	Its junction with Hallhouse Lane	For a distance of 15.5 metres in an easterly direction

- (b) In relation to Schedule Nine, the following entries shall be added to Schedule Nine to the Order:-

Rectory Lane, Standish	South	A point 73 metres east of its junction with Oakengates	For a distance of 31.6 metres in an easterly direction

Mather Lane, Leigh	East	A point 127.5 metres south of its junction with Chapel Street	For a distance of 25.3 metres in a southerly direction
--------------------	------	---	--

Kirkhall Lane, Leigh	South	Its junction with Cavendish Street	For a distance of 25.3 metres in a westerly direction

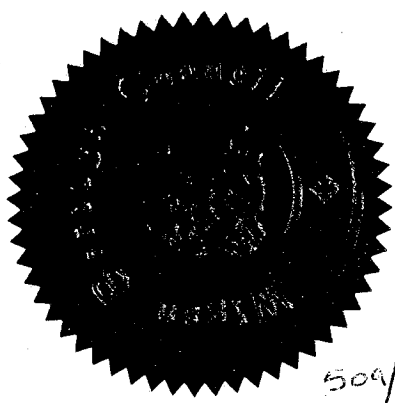
Manchester Road, Leigh	South	A point 15.5 metres east of its junction with Hallhouse Lane	For a distance of 43.6 metres in an easterly direction
---------------------------	-------	--	--

Church Lane, Lowton	East	A point 67 metres north east of its junction with Ranworth Drive	For a distance of 32 metres in a north easterly direction
------------------------	------	--	--

3. Save as provided in relation to the above amendments. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 shall remain in force.
