THE WIGAN BOROUGH (DECriminalISATION OF PARKING)
(VARIOUS ROADS IN WIGAN BOROUGH)
(TRAFFIC REGULATION CONSOLIDATION) ORDER 2004
(AMENDMENT NO. 27) ORDER 2008

The Wigan Borough Council in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other powers enabling it in that behalf hereby makes the following Order:-

1. This Order may be cited as The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 27) Order 2008 and shall come into operation on 7th April 2008.


