(VARIOUS ROADS IN WIGAN BOROUGH) (TRAFFIC REGULATION CONSOLIDATION)  
ORDER 2004  
(AMENDMENT NO. 122) ORDER 2008**

The Wigan Borough Council, in exercise of its powers under Section 1 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004, hereby makes the following Order-

1. This Order may be cited as the Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough) (Traffic Regulation Consolidation) Order 2004 (Amendment No. 122) Order 2008 and shall come into operation on 6<sup>th</sup> May 2008.
2. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 is hereby amended as follows:-
  - (a) In relation to Schedule One, the following entry/entries shall be deleted from Schedule One to the Order:-

Slag Lane	Both	Its junction with Golborne Road	For a distance of 60 metres in a north easterly direction
-----------	------	---------------------------------	---

In relation to Schedule Two, the following entry/entries shall be deleted from Schedule Two of the Order: -

Slag Lane	Both	A point 60 metres north east of its junction with Golborne Road	A point 153 metres north east of its junction with Golborne Road

In relation to Schedule Four, the following entry/entries shall be deleted from Schedule Four of the Order: -

Slag Lane	Both	Its junction with Golborne Road	For a distance of 60 metres in a north easterly direction

- (b) In relation to Schedule One, the following entries shall be added to Schedule One to the Order:-

Chapel House Mews	Both	Its junction with Slag lane	For a distance of 16 metres in a north westerly direction
-------------------	------	-----------------------------	---

Slag Lane	Both	Its junction with Golborne Road	For a distance of 72 metres in a north easterly direction
-----------	------	---------------------------------	---

In relation to Schedule Two, the following entries shall be added to Schedule Two of the Order:-

Slag Lane	Both	From a point 72 metres north east of its junction with Golborne Road	To a point 153 metres north east of its junction with Golborne Road
-----------	------	--	---

In relation to Schedule Four, the following entries shall be added to Schedule Four of the Order:-

Slag Lane	Both	From its junction with Golborne Road	For a distance of 72 metres in a north easterly direction
Chapel House Mews	Both	From its junction with Slag Lane	For a distance of 16 metres in a north westerly direction

3. Save as provided in relation to the above amendments. The Wigan Borough (Decriminalisation of Parking) (Various Roads in Wigan Borough)(Traffic Regulation Consolidation) Order 2004 shall remain in force.
